CHAPTER F-9

FINANCIAL ADMINISTRATION ACT

FINANCIAL ASSISTANCE ENFORCEMENT REGULATIONS

Pursuant to section 79 of the *Financial Administration Act*, R.S.P.E.I. 1988, Cap. F-9, Council made the following regulations:
