CHAPTER L-5

PRINCE EDWARD ISLAND LANDS PROTECTION ACT

FORMS REGULATIONS

Pursuant to clause 17(1)(c) of the *Prince Edward Island Lands Protection Act* R.S.P.E.I. 1988, Cap. L-5, Council made the following regulations:

- (g) Form 5B - self-calculating land holding disclosure statement for a corporation pursuant to subsection 11(3) of the *Prince Edward Island Lands Protection Act*;

NOTE: In accordance with section 9.(1) of the P.E.I. Lands Protection Act special conditions may be required. section 9.(1) states:

- 9.(1) The Lieutenant Governor in Council may impose such conditions on a permit issued under section 4 or 5 as he may consider expedient including a condition
- (a) that the land not be subdivided except for
 - (i) use for the purposes of agricultural, forestry or fisheries production,
 - (ii) conservation use pursuant to a designation as a natural area under the *Natural Areas Protection Act* R.S.P.E.I. 1988, Cap. N-2, an archaeological site under the *Archaeological Sites Protection Act* R.S.P.E.I. 1988, Cap. A-17 or a heritage place under the *Heritage Places Protection Act* Stats. P.E.I. 1992, c.31,

1. AUTHORITY

Where the sale or purchase of real property is subject to the approval of the Lieutenant Governor in Council pursuant to the Prince Edward Island Lands Protection Act R.S.P.E.I. 1988, L-5, the Lieutenant Governor in Council may make it a condition of consenting to the

sale that the land be identified for non-development use pursuant to the Land Identification Regulations made under the Act.

2. Eligibility

Any parcel of land in excess of five (5) acres or having in excess of 165 feet of shore frontage that is the subject of an application pursuant to the Act may be required to be identified except where planning approval has been granted for development of the entire parcel.

Land identified for non-development use under a land identification agreement cannot be further subdivided or used for commercial or industrial purposes.
