CHAPTER M-13

MUNICIPALITIES ACT MUNICIPAL OFFENCE TICKET REGULATIONS

(Approved by Her Honour the Lieutenant Governor in Council dated 31 May 2007.)

Pursuant to section 67 of the *Municipalities Act* R.S.P.E.I. 1988, Cap. M-13, Council made the following regulations:

1. In these regulations, "Act" means the *Municipalities Act* R.S.P.E.I. Definitions 1988, Cap. M-13. (EC353/07)

2. For the purposes of section 58.1 of the Act, the prescribed form for a Prescribed form municipal offence ticket is as set out in the Schedule to these regulations. (EC353/07)
