CHAPTER M-13

MUNICIPALITIES ACT

REGULATIONS

Pursuant to section 67 of the *Municipalities Act* R.S.P.E.I. 1988, Cap. M-13, Council made the following regulations:

- **1.** For the purposes of subsection 27(4) of the Act the amount prescribed Prescribed amount is \$50,000. (EC252/84; 18/92)
- **2.** The form of oath of office to be taken by the mayor or chairman and Form 1 the councillors of a municipality pursuant to section 20 of the Act is set out in Form 1 of the Schedule. (EC252/84)
- **2.1** The form of notice of election for the purposes of clause 49(3)(d) of Form 1.1 the Act and subsection (6) of Schedule 2 of the Act is set out in Form 1.1 of the Schedule. (EC252/84; 356/93)
- **3.** The form of nomination papers for the purposes of clauses 48.1(2)(a) Form 2 and 49(3)(b) of the Act and subsection (8) of Schedule 2 of the Act is set out in Form 2 of the Schedule. (EC356/93)
- **4.** The form of warrant to the returning officer directing him to hold a Form 3 poll pursuant to subsection (15) of Schedule 2 of the Act is set out in Form 3 of the Schedule. (EC252/84)
- **5.** The form of the oath of an elector voting at an advance poll pursuant Form 4 to subsection (18) of Schedule 2 of the Act is set out in Form 4 of the Schedule. (EC252/84)
- **6.** The form of the oath of office to be taken by the returning officer or Form 5 deputy returning officer pursuant to subsection (21) of Schedule 2 of the Act is set out in Form 5 of the Schedule. (EC252/84)
- **7.** The form of the oath of office to be taken by a poll clerk pursuant to Form 6 subsection (22) of Schedule 2 of the Act is set out in Form 6 of the Schedule. (EC252/84)
- **8.** The form of declaration by an elector whose name is not entered on Form 7 the list of electors pursuant to subsection (24) of Schedule 2 of the Act is set out in Form 7 of the Schedule. (EC252/84)
