EXECUTIVE COUNCIL ACT
MINISTER OF COMMUNITY AND CULTURAL AFFAIRS
AUTHORITY TO ENDORSE
THE CANADIAN POLICY AGAINST DOPING IN SPORT (2004)

Pursuant to clauses 10(a) and (b) of the *Executive Council Act* R.S.P.E.I. 1988, Cap. E-12 Council authorized the Minister of Community and Cultural Affairs to endorse The Canadian Policy Against Doping in Sport (2004) which provides for cooperation in the development and promotion of effective anti-doping policies, strategies and programs, such as more particularly described in the draft policy statement.

Council noted that the federal, provincial and territorial ministers responsible for sport and recreation intend to convey the endorsement of their respective jurisdictions at their annual conference in April 2004.

PRINCE EDWARD ISLAND
LANDS PROTECTION ACT
PROPERTY NO. 817338, LOT 5, PRINCE COUNTY
IDENTIFICATION FOR NON-DEVELOPMENT USE
AMENDMENT

Pursuant to subsection 9(2) of the *Prince Edward Island Lands Protection Act* R.S.P.E.I. 1988, Cap. L-5, Council amended the condition of non-development use made pursuant to section 2 of the Land Identification Regulations (EC606/95) in respect of approximately fifty decimal five eight (50.58) acres of land, being Provincial Property No. 817338 located in Lot 5, Prince County, Prince Edward Island and currently owned by W.P. Griffin Inc. of Elmsdale, Prince Edward Island.

Council noted that this amendment will enable subdivision of a parcel of land of approximately zero decimal two one (0.21) acres, and is SUBJECT TO the subdivided parcel being consolidated with the adjacent Provincial Property #37267. Further, Council determined that following subdivision, identification for non-development use shall continue to apply to the remaining land.

This Order-in-Council comes into force on 24 February 2004.

TRANSFER OF CROWN LAND TO

**SCHOOL ACT
EDUCATION NEGOTIATING AGENCY REGULATIONS
AMENDMENT**

Pursuant to section 147 of the *School Act* R.S.P.E.I. 1988, Cap. S-2.1, Council made the following regulations:

1. Section 1 of the *School Act* Education Negotiating Agency Regulations (EC45/95) is revoked and the following substituted:

1. (1) The Education Negotiation Agency shall be composed of the following members appointed by the Minister: Members of the Agency

- (a) three representatives of the Department of Education;
- (b) one representative nominated by the Treasury Board;
- (c) not less than two and not more than three representatives of the school boards, nominated by the school boards from employees who are non-union supervisory staff.

(2) Not more than one representative of any school board may be appointed as a member of the Education Negotiation Agency pursuant to clause (1)(c). Not more than one representative of any school board

2. These regulations come into force on March 6, 2004.

EXPLANATORY NOTES

SECTION 1 removes the reference to nomination by a private firm and simplifies the appointment of members.

SECTION 2 provides for the commencement of these regulations.

**SCHOOL ACT
SCHOOL CALENDAR REGULATIONS
AMENDMENT**

Pursuant to section 147 of the *School Act* R.S.P.E.I. 1988, Cap. S-2.1, Council made the following regulations:

1. Subsection 7(3) of the *School Act* School Calendar Regulations (EC539/95) is revoked and the following substituted:

(3) The first instructional day in a school year shall be on a day following the first school day in a school year, as determined by the Minister. ^{First instructional day}

2. Subsection 11(2) of the regulations is amended by the deletion of the words “fourth school day” and the substitution of the words “third school day”.

3. These regulations come into force on March 6, 2004.

EXPLANATORY NOTES

SECTION 1 determines the date of the first instructional day in a school year.

SECTION 2 provides that the last instructional day will be the third school day prior to and including the last school day.

SECTION 3 provides for the commencement of these regulations.
