Pursuant to subsection 9(2) of the *Prince Edward Island Lands Protection Act* R.S.P.E.I. 1988, Cap. L-5, Council amended the condition of non-development use made pursuant to section 2 of the Land Identification Regulations (EC606/95) in respect of approximately twenty-two decimal nine five (22.95) acres of land, being Provincial Property No. 830273 located in Lot 22, Queens County, Prince Edward Island and currently owned by Trustees for Four Winds Communal Trust of Emmerson, Manitoba.

Council noted that this amendment will enable subdivision of a parcel of land of approximately zero decimal four (0.4) acres and is SUBJECT TO the subdivided parcel being consolidated with the adjacent Provincial Property No. 767921. Further, Council determined that following subdivision, identification for non-development use shall continue to apply to the new parcel as well as to the remaining land.

Pursuant to subsection 9(2) of the *Prince Edward Island Lands Protection Act* R.S.P.E.I. 1988, Cap. L-5, Council amended the condition of non-development use made pursuant to section 2 of the Land Identification Regulations (EC606/95) in respect of approximately twenty-two decimal nine five (22.95) acres of land, being Provincial Property No. 830273 located in Lot 22, Queens County, Prince Edward Island and currently owned by Rit-Jan DeBoer and Jacintha DeBoer, both of Hazel Grove, Prince Edward Island.

Council noted that this amendment will enable subdivision of a parcel of land of approximately zero decimal three three (0.33) acres and is SUBJECT TO the subdivided parcel being consolidated with the adjacent Provincial Property No. 767921. Further, Council determined that following subdivision, identification for non-development use shall continue to apply to the new parcel as well as to the remaining land.
