PRINCE EDWARD ISLAND  
LANDS PROTECTION ACT  
PROPERTY NO. 657445, LOT 8, PRINCE COUNTY  
IDENTIFICATION FOR NON-DEVELOPMENT USE  
AMENDMENT

Pursuant to subsection 9(2) of the *Prince Edward Island Lands Protection Act* R.S.P.E.I. 1988, Cap. L-5, Council amended the condition of non-development use made pursuant to section 2 of the Land Identification Regulations (EC606/95) in respect of approximately thirty-five (35) acres of land, being Provincial Property No. 657445 located in Lot 8, Prince County, Prince Edward Island and currently owned by D.G.S. Farms Ltd. of West Point, Prince Edward Island.

Council noted that this amendment will enable placement of a 66 foot wide right-of-way over approximately one decimal five (1.5) acres of the parcel and determined that identification for non-development use shall continue to apply to the parcel.

This Order-in-Council comes into force on 15 June 2004.

WHEREAS in and by section 23 of Chapter 34 of the Acts passed by the  
Legislature of Prince Edward Island in the 3rd Session thereof held in the year  
2002 and in the fifty-first year of Our Reign intituled the "Maritime Provinces  
Higher Education Commission Act" it is enacted as follows:

“This Act comes into force on a date to be fixed by proclamation of the  
Lieutenant Governor in Council.”,

AND WHEREAS it is deemed expedient that section 22 of the said Act, Stats.  
P.E.I. 2002, 3rd Session, c. 34 should come into force on the 15th day of June,  
2004,

NOW KNOW YE that We, by and with the advice and consent of our  
Executive Council for Prince Edward Island, do by this Our Proclamation  
ORDER AND DECLARE that section 22 of the said Act being the "Maritime  
Provinces Higher Education Commission Act" passed in the fifty-first year of Our  
Reign shall come into force on the fifteenth day of June, two thousand and four of  
which all persons concerned are to take notice and govern themselves  
accordingly.
