 IDENTIFICATION FOR NON-DEVELOPMENT USE  
 AMENDMENT

Pursuant to subsection 9(2) of the *Prince Edward Island Lands Protection Act* R.S.P.E.I. 1988, Cap. L-5, Council amended the condition of non-development use pursuant to section 2 of the Land Identification Regulations (EC606/95) in respect of approximately twenty-five decimal five two (25.52) acres of land, being Provincial Property No. 333179 located in Lot 57, Queens County, Prince

Edward Island and currently owned by Hilltop Farm Ltd. of Orwell Cove, Prince Edward Island.

Council noted that this amendment will enable subdivision of a parcel of land of approximately zero decimal six one (0.61) acres and is SUBJECT TO the subdivided parcel being consolidated with the adjacent Provincial Property No. 412635. **EC2007-467****REVENUE TAX ACT  
REGULATIONS  
AMENDMENT**

Pursuant to section 57 of the *Revenue Tax Act* R.S.P.E.I. 1988, Cap. R-14, Council made the following regulations:

**1. Subsection 40(3) of the *Revenue Tax Act* Regulations (EC262/60) is amended by the deletion of the words “\$50” and the substitution of the words “\$200”.**

**2. These regulations come into force on August 4, 2007.**

**EXPLANATORY NOTES**

This amendment increases the annual license fee for an entertainment device from \$50 to \$200.
