
# **Tourism Sector Monitor • September 2001**

# **Highlights**

### **Room revenue**

For the fifth consecutive month, room revenues in BC fell (-0.9%) in **June**. The driving force behind this was the Mainland Southwest (-2.1%) where revenues have been weak since the beginning of the year, and the Northeast (-10.7%). The largest gains were made in the North Coast (+3.8%) followed by the Cariboo (+2.1%) and Vancouver Island/Coast (+2.0%).



### **Visitor Entries**

After three months of decline, visitor entries to BC remained fairly flat (+0.1%) in **July.** A small increase in entries from the US (+0.3%) was dominated by a decline in visitors from overseas (-0.7%).

### Other indicators

In **July**, restaurant, caterer and tavern receipts grew 6.5% from the same period last year. Full service restaurants saw the largest increase (+10.6%).

Passenger traffic at the Vancouver International airport slipped 0.4% in **June** from the same period last year. At the Victoria airport, passenger traffic rose 12.5% in **July** compared to July 2000. Both vehicle traffic (+3.6%) and passenger traffic (+1.1%) on the BC Ferries in **July** was up from the same month last year.


# **Tourism Trends**


### Room Revenue


Despite declines in only three regions, room revenues in BC continued on a downward trend in June, falling 0.9%. The Northeast region saw the largest fall (-10.7%). Drops in Richmond and Downtown Vancouver pushed revenues in the Mainland Southwest down 2.1%. The Kootenay region (-1.4%) also saw declines. The largest gains were made in the North Coast where revenues rose 3.8%. Other regions that saw growth included Vancouver Island/Coast (+2.0%) and the Cariboo (+2.1%).

In the second quarter of 2001, room revenues dropped 4.3%. The driving force behind this fall was the Mainland Southwest where revenues were down 7.2%. The Northeast boasted the highest growth in the second quarter, with revenues up 10.1%. A weak performance by the Central Kootenay regional district led to a 6.8% fall in revenues in the Kootenay region.

**Note:** All comparisons for "Tourism Trends" are seasonally adjusted unless stated otherwise. All comparisons are to the previous month except where noted.









# **Visitor Entries**

International traveller entries to BC levelled off (+0.1%) in July, after three months of decline. Overseas entries dropped (-0.7%) due in part to a fall in entries from European (-3.3%) and Oceanic (-2.2%) countries. Entries from the US rose 0.3% despite a fall (-1.0%) in same-day trips.

The number of Canadian re-entries via BC was up 0.3%. Canadian same-day auto trips to the US dropped 1.7% but overseas re-entries grew 1.5%.

Canadian re-entries levelling off







## **Other Tourism Indicators**

Restaurant, caterer and tavern receipts continued to grow, reaching \$479.5 million in July, a new record. Receipts were up 6.5% from July 2000 levels. Full service restaurant receipts rose 10.6% and sales from drinking places grew 7.7% from the same period last year.

### Despite a decline in the number of businesses, revenue in the food and beverage service industry is showing strong growth over last year.
