CONTEST RULES AND REGULATIONS

CONTEST DETAILS

Qulliq Energy Corporation (QEC) is running a 6-month “Scratch and Win” contest for QEC customers (“*Customers*”). Each month, a new scratch card will arrive in the mail with your power bill.

Each monthly scratch card will contain a fact about energy conservation , with a multiple-choice question below. Each question will have three (3) corresponding answers. Customers must choose the answer that **they believe to be correct**, and then scratch the silver scratch-off circle that corresponds to that answer. If you have in fact chosen the correct answer, you may then scratch the silver square on the right side of the card to reveal whether or not you have won a prize.

HOW TO PARTICIPATE

1. Customers will be receiving a Scratch Card in their monthly power bill statement.
2. Any entries without adequate contact information will be removed from the contest. “*Adequate contact information*” refers to the name, address and telephone number of the **QEC customer participating** in the contest.

3. The contest is ongoing over the course of 6 months. Customers can enter up to 6 times.
4. It is imperative that only the **CORRECT** answer circle is scratched. The only cards that will be accepted are cards that have only one answer circle scratched, on one side of the card.
5. Scratch cards with circles scratched on both sides of the card will **NOT** be accepted in this contest.
6. Customers have roughly a 1 in 1200 chance of obtaining a winning card in with their power bill statement.

ELIGIBILITY

- A. QEC employees, management, and Board Members, which include all employees of Nunavut Power and the Nunavut Energy Centre, as well as their immediate family members, (living in the same household) are excluded from entry into this contest.
- B. Any cards that have been tampered with or defiled will automatically be removed from the contest.
- C. By entering the contest, the customer agrees to abide by the contest rules and all decisions of the contest organizers, which are final.
- D. By entering the contest, customers consent to the use of their entry, name, city of residence in publicity that may be carried out by QEC without further notice or compensation.
- E. No substitution of prizes will be permitted.

PRIZES

All legitimate winning cards will be entered into a monthly, random draw for the grand prize of \$250.00 off of subsequent power bills. All of the contestants who do not win the grand prize will receive \$50.00 off their next power bill. Secondary prizes must be claimed by March 31st, 2008, at which time any outstanding monies will become void.

AQIMANAHUANUT ATUQQUYAUHIMAYUT

AQIMAYUKHANUT NAUNAITQUTAIT

Aulayunnautiliriyikkut (Qulliq Energy Corporation - QEC) piliktut arvinilikni tatqiqhiutini “Kittuqlugu Aqimayaakni” akimayaghanik ukununga ilauyuni QECKuni (“*Aqilikhivaktuni*”). Tatkikhiut tikitkaangat, nutaak kittuqtughak titiraq tikinniaktuq titiraqhaqvingnut iluani akiliktakhangnut aulatjutinut.

Tatkikhiut tikitkaangat kittuqtughak titiraq titirakakniaktuq itquumayumik ihuaqtumik atuqtakhanik aulatjutinut , qiuylaghniklu aallatkiinik attaani. Apihuut atauhik pingahunik itkuumayaghainik naunaiyaivikakniaktut. Niuvikpaktut piyughat qiuylakhamingnik **inmik itkuumanahugiyamingnik**, kittuqlugutauk kallalik kiplagiktumik kaimatlugiktuq ihuaqkat apihuutimut. Piguvit ihuaqtumik qiutjutaanik apihuutimut, kittutjavat taamna kiplariktuq qitqariqtuq talikpiani titirkap naunairiangani aqimayaakhangnik taffuminga aqimayaqhamik.

QANUK AQIMANA HUGITTAAKNI

1. Niuvikpaktut aqiliqhiyut tuyuqhixniaktut Kittuqtakhamingnik Titiraqmik tuyuqhikniaktut aulatjutinut aqiliqtakhamingnut naunaitqutighainut.
2. Kitulikaak uuktuqtut illiringitpata iniqhihimaittumik naunaiyaktautjutikhanik piiktauniaktut aqimanahugittunit. "*Ihuaqtut tuhaktitiyaami naunaitqutit*" ukuat atia, tuyuqvikhaa unalu hivayavikhaa nappaa ukunanga ***QECKUT AQILIQHIYUT UUKTUQNAHUANI*** aqimanahuaktuni.
3. Aqimanahugitniaktut taima arvinilikni tatqikhiutini. Aqilikhinahuat uuktuinarialgit arviniliknik uuktuqlutik.
4. Piyuqhauyuhi **IHUAQ TUQ** qiutjutaa qaimatlugiktuq kittuqtauyughak. Taamnaitnak titiraq piyauniaktut ukuat titirkat atauhiinnakmik kittuqhimayut qiutjutit, ikluinnaanut titirkap.
5. Kitturaghah titirkat qaimatlugiktunik kittuqhimayulgut iglugiiktunik titirkami **PIYALIMAITTUT** uumani aqimatjutikhami.
6. Aqiliqhiyut piyut atuhikmik 1200ni aqimaniaktut aqimayaqhamik titiraqmik talvani akiliqtakhamingnut naunaitqutaani aulatjutinut.

PIINNAGIALGIT

- A. QECKuni havaktut, ataniuyut, ilauuyut katimaviani, ukuatlu tamaita havaktut (Nunavut Power) Nunavunmi Aulatjutikakvingni ukuatlu (Nunavut Energy Centre) Nunavunmi Ihuaqtumik Atuqtitiyut Aulatjutinik Havakviat, ilaitlu angayuqqaangitlu, (iglukatigiiktut) uuktulimaittut aqimanahugitlutik uumani aqimayaghanit.
- B. Titirkat ihuinaakhimayumik ihuaqhaqtauhimayut piiktitauniaktut uumanga aqkimayaghanit.
