Subject: NEW INTERPROVINCIAL BILLING RATES FOR OUTPATIENT HOSPITAL SERVICES EFFECTIVE APRIL 1. 2006

The Interprovincial Health Insurance Agreements Coordinating Committee (IHIACC) has introduced updated interprovincial hospital billing rates for outpatient services provided on or after April 1, 2006.

Regional Ministry of Health and Long-Term Care (MOHLTC) Finance Managers will provide the new outpatient billing rates to individual hospitals. The document attached outlines the new interprovincial outpatient billing rates for April 1, 2006.

In order to efficiently process your hospital's reciprocal billing claims, the ministry requires that all invoices contain your hospital's corporation 3-digit facility number and the correct rate. At this time, consistent with national protocols, given that most provinces and territories reciprocal billing systems only accept the International Statistical Classifications of Diseases ICD-9-CM coding, Ontario hospitals must also submit their claims using ICD-9-CM reporting.
