Commissioner Gwen Boniface

Sworn in as the first female Commissioner of the Ontario Provincial Police in 1998, Gwen Boniface retired from that post in 2006 to join a newly established oversight Inspectorate for Ireland's 13,000 member National Police Service, the An Garda Siochana.

Starting her career at the former Downsview (now Toronto) Detachment in 1977, she served as coach officer and completed special assignments including security details and plainclothes duties at the same time as she earned a bachelor of arts degree at York University and gave birth to her son, Brett. Calling herself a "continuous learner by nature", she took leave from the OPP to pursue a law degree (she was called to the Ontario Bar in 1990) but was back in uniform each summer.

During her 30 years in policing, Commissioner Boniface was vested in the Order of Ontario (2001) and named Commander of the Order of Merit of the Police Forces. She was the first female president of the Canadian Association of Chief of Police and the first

Canadian to serve as General Chair of the International Association of Chiefs of Police's Division of State and Provincial Police. Commissioner Boniface was also the first recipient of Ontario's Leading Women, Building Communities Award.

PROVINCIAL COMMAND - CORPORATE SERVICES

During the past 12 months, Corporate Services has experienced significant change with the realignment of functions and accountabilities to ensure that the infrastructure required will support efficient police services responsive to the needs of our front-line officers.

Our People: Many initiatives are underway that will enable people at all levels of the organization (from job applicants, new recruits, front-line employees, volunteers and supervisors, to senior executives) to demonstrate their commitment to the values and ethics of the OPP and continually earn the public's trust. This commitment will be regularly evaluated as part of improved employee selection, business planning and performance management systems.

Also, our organization strives to provide professional policing services to the province of Ontario, and, in support of this resolve, the OPP endeavours to mirror the diversity of our great province through hiring practices.

High Performance: Anticipation of business service delivery needs is vital. The Corporate Services Command is integrating the values of the OPP in how it conducts its business by placing an increased emphasis on quality of service, customer satisfaction and relationships.

Infrastructure Addressed: The OPP is developing an operational plan and information technology strategy to support several front-line initiatives such as online requisitioning of uniforms and equipment. To optimize our service to the public, the upgrading of detachment buildings and other field locations remains a high priority – the OPP is working hand-in-hand with our Ministry colleagues to expedite construction and renovation of these structures, as well as government housing.

PROVINCIAL COMMAND - FIELD OPERATIONS

Field Operations is committed to working continually to earn the confidence of the citizens of and visitors to Ontario – a confidence that will not be taken for granted. Our women and men, both sworn officers and civilians, provide the best and most professional lawenforcement service possible and strive to build a culture of trust and open, honest dialogue with the communities they serve.

The Field Operations Command structure consists of 155 detachment and satellite locations, administered by five Regional Headquarters in London, Smiths Falls, Orillia, North Bay and Thunder Bay. Policing services are provided to over one million square kilometers of Ontario, and over 20,000 km of highways are patrolled.

This Command is staffed by 3,500 uniform members and 1,150 civilians, and is proud of its active Auxiliary force of 840 members who supply ongoing support to front-line service delivery.

Also, the Field Operations Command is charged with providing policing services:

- · for parts of Ontario that do not have municipal police forces other than municipal law enforcement officers; and
- all navigable bodies and courses of water in Ontario, except those that lie within municipalities designated by the Solicitor General.

The OPP fleet consists of 3,880 pieces of equipment, including general patrol vehicles, motorized snow vehicles, all-terrain vehicles, marine equipment and aircraft.

Field Operations Command also includes the Field Support Bureau and the First Nations and Contract Policing Bureau and also develops and manages specialized policing service contracts; support services agreements and framework agreements to supply OPP services.

PROVINCIAL COMMAND - INVESTIGATIONS/ORGANIZED CRIME



The Provincial Command of Investigations/Organized Crime meets the challenges of 21st century criminal behaviour head on through the highly technical and specialized investigative expertise of more than 800 members and 160 civilians deployed across the province.

Comprised of three bureaus, as well as the Chief Firearms Office and the Alcohol and Gaming Commission of Ontario, this Command plays a major role in ensuring the safety and security of the people of Ontario.

Last year, its specialty teams dealt with ever-rising levels of electronic and organized crime, abuse of our most vulnerable citizens and international or home-grown terrorism, just to name a few.

As well, Investigations/Organized Crime established leadership roles in co-ordinated projects with its justice partners of all levels, from municipal police services to international law-enforcement agencies. These joint-forces initiatives included Drug Enforcement, the Provincial Violent Crimes Linkage Analysis System (ViCLAS) Centre, the Organized Crime Section, the Provincial Weapons Enforcement Unit, the Ontario Sex Offender Registry, the Illegal Gambling Unit, the Provincial Auto Theft Team, the Provincial Assets Forfeiture Unit and the Biker Enforcement Unit.

Committed to the ongoing development of a strategy that assesses operational priorities and directs appropriate resources at criminal targets, this Command focused its investigations on effective intelligence gathering, comprehensive analysis and information sharing with all justice partners. Based on four critical components, securing the right intelligence, strategically analysing that intelligence, setting priorities and targeting enforcement, this strategy means this Command continued to evolve, ensuring OPP's ability to respond to new challenges.

PROVINCIAL COMMAND - TRAFFIC SAFETY

The creation of the Provincial Command for Traffic Safety and Highway Safety Division (HSD) within the OPP has provided an unprecedented opportunity to positively impact and mitigate the hundreds of fatalities that occur each year on Ontario's highways, trails and waterways.

Leadership, Professionalism and Visibility have become the cornerstones of the HSD and are the touchstone of this Provincial Command.

Recognized throughout North America as a leader in traffic safety, the OPP has enhanced its capacity to analyze successes in traffic issues, thus providing the organization with the opportunity to rise above the culture of status quo. The OPP will continue to demonstrate true leadership by embracing and incorporating the principles of the Province.







Public Complaints in the OPP-A Comparison Over Three Years



2006 Public Complaints Represented Less than 1% of Total Calls for Service





RESULTS DRIVEN POLICING/ORGANIZATIONAL CHART

The fundamental elements of policing in the 21st century – adequacy, effectiveness, efficiency, accountability and transparency – have fused into the OPP's high-performance initiative known as Results Driven Policing or RDP.

In keeping with organizational commitments to front-line policing and excellence in serving the citizens of Ontario, the OPP is implementing the accountability framework so its officers can ensure their efforts are making a difference.

RDP, modeled around a proven system that is credited with dramatic decreases in crime and victimization levels across the United States and Australia, is a relatively new concept to Canada. Initiated by Commissioner Julian Fantino in November, 2006, RDP aims to improve community safety through targeted crime reduction, traffic enforcement and increased support for field and front-line service delivery.

Fundamentally, RDP establishes responsibility for producing crime reduction and traffic law enforcement results, and accountability for increasing public safety and community confidence in front-line policing.

Initially RDP will change how OPP officers and civilian employees address public safety issues, how resources are allocated to meet these identified issues and how the merging of technology and statistical analysis results in front-line policing benefits.

For example, RDP reports identify a significant increase to car thefts in certain areas that fall under the jurisdiction of several OPP detachments. A criminal analyst at the regional level studies the overall situation while officers from the various detachments review the specific occurrences. Once potential causes are identified, a strategic crime plan is developed and implemented to counter the trend.

Finally the most critical step in the proactive RDP process – the reporting of results and repeated evaluations until success is achieved.
