

Ontario Influenza Bulletin 2005-2006 Season

SURVEILLANCE WEEK 4 (January 22 to 28, 2006)

This issue of the Ontario Influenza Bulletin provides information on the surveillance period from January 22 to 28, 2006. The analysis for this issue occurred on Thursday February 2, 2006, therefore all data is current to that date.

During week 4 of 2006, influenza activity in Ontario increased compared to that of the previous week. Five sporadically occurring cases of influenza (4 influenza A and 1 unspecified) were reported through iPHIS. In addition, 2 institutional outbreaks attributed to influenza A, one in an acute care hospital and the other in a retirement home, were also reported. The highest level of influenza activity in Ontario remains at 'localized activity', reported in Eastern, Southwest and Central West regions.

Influenza Subtype(s):

During Week 4, 2,579 isolates were received by the Public Health Agency of Canada, with a total of 97 and 110 testing positive for influenza A and B respectively. The majority of the influenza A isolates (47) were from British Columbia (48.5%), Alberta 26(26.8%) and Ontario 11(11.3%). The majority of the influenza B isolates (55) were from Alberta (50.0%), British Columbia 37 (33.6%) and Saskatchewan 15 (13.6%).*

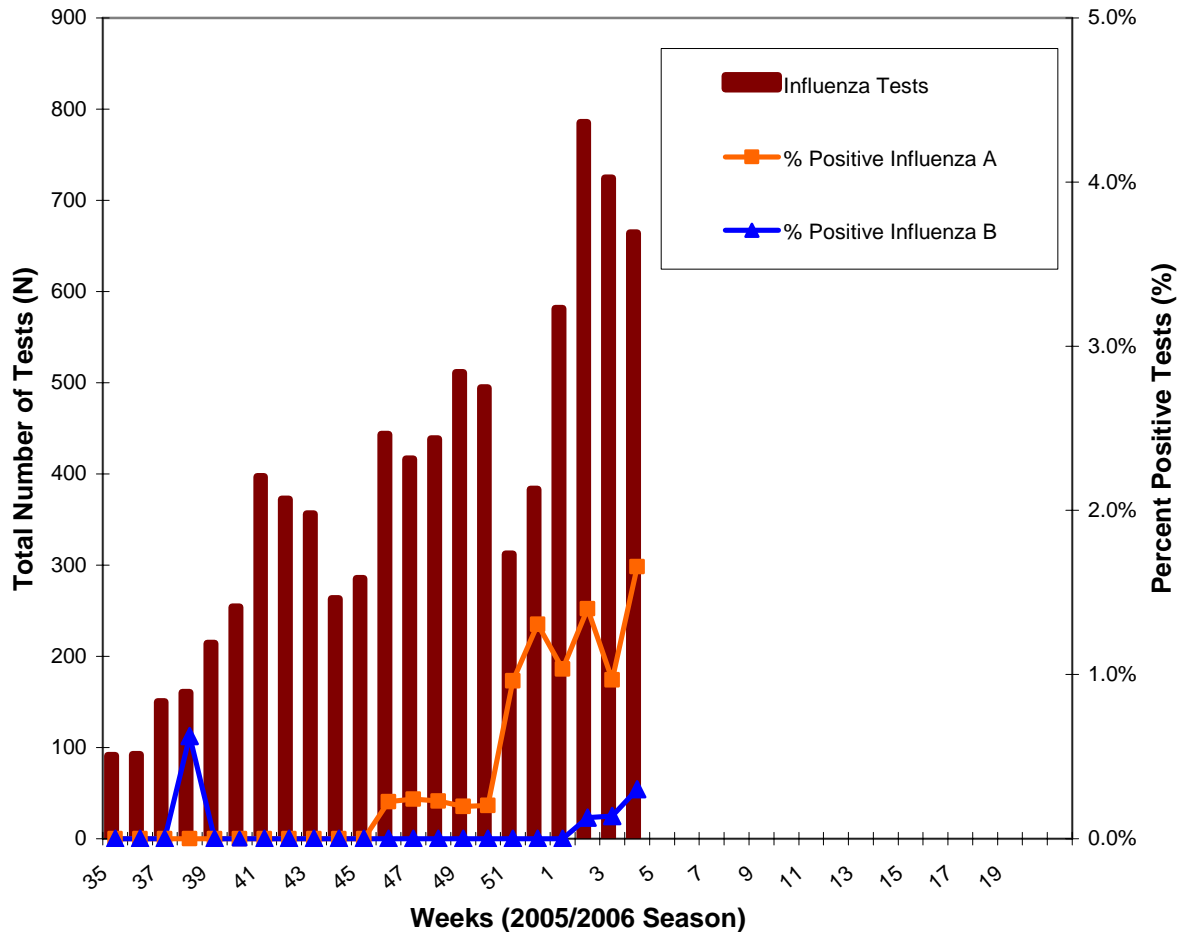
Since the start of the 2005-2006 influenza season, the National Microbiology Laboratory (NML) has antigenically characterized 125 influenza viruses: 74 A/California/07/2004(H3N2)-like viruses (49 in British Columbia, 6 in Alberta, 3 in Saskatchewan & 16 in Ontario), 1 A/New Caledonia/20/1999(H1N1)-like virus (Quebec), 47 B/Hong Kong/330/2001-like viruses (3 in the Yukon, 1 in British Columbia, 35 in Alberta, 6 in Saskatchewan & 2 in Ontario) belonging to the B/Victoria/2/1987 lineage, and 3 B/Shanghai/361/2002-like viruses (British Columbia, Alberta & Ontario) belonging to the B/Yamagata/16/1988 lineage.**

Note: The 2005-2006 season Canadian vaccine contains an A/New Caledonia/20/1999(H1N1)-like, an A/California/7/2004(H3N2)-like, and a B/Shanghai/361/2002-like virus strain.

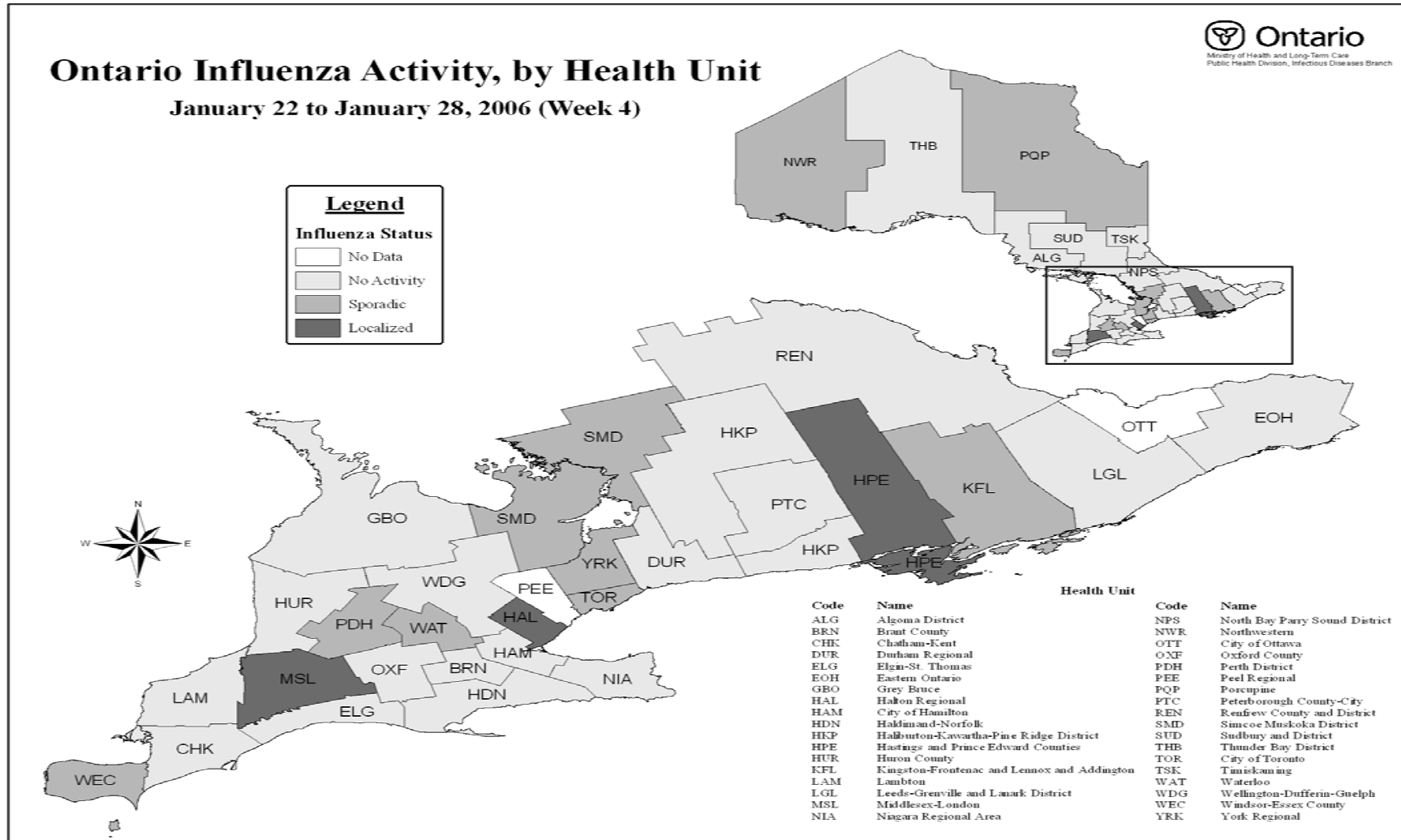

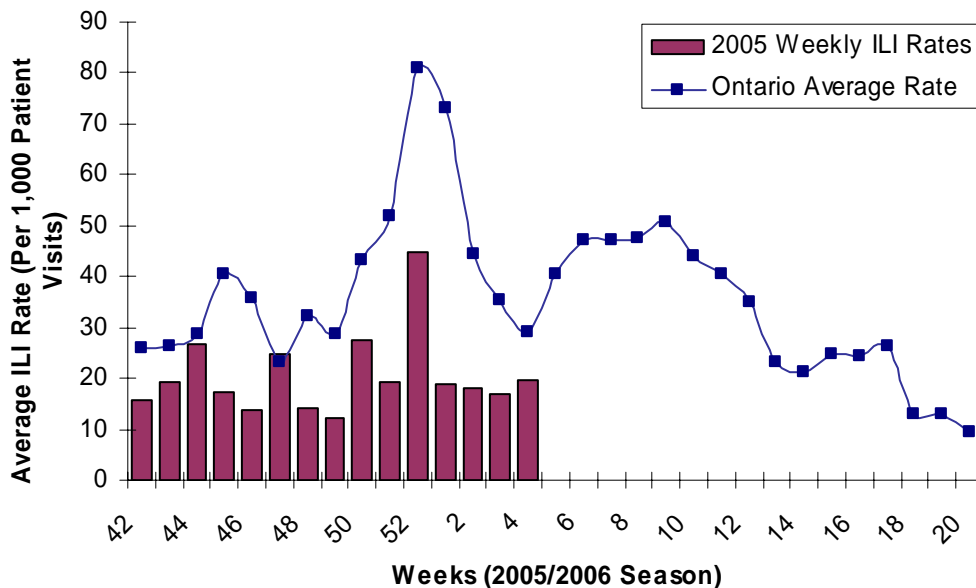
Figure 2: Influenza activity* in Ontario by health unit, (January 22 to 28, 2006).

APPENDIX

Definitions for influenza activity levels:

No Data: No activity report corresponding to the surveillance week was received at the Ministry of Health and Long-Term Care Call Centre by the Tuesday (at 4 p.m.) following the end of the surveillance period.

No Activity = No ILI and no laboratory-confirmed cases* or outbreaks occurred.

Sporadic: sporadically occurring ILI **AND** laboratory-confirmed influenza* with NO outbreaks detected within the influenza surveillance region†

Localized: sporadically occurring ILI **AND** laboratory-confirmed influenza* together with outbreaks of ILI in schools and worksites or laboratory confirmed influenza in residential institutions occurring in less than 50% of the influenza surveillance region(s)

Widespread: sporadically occurring ILI **AND** laboratory-confirmed influenza* together with outbreaks of ILI in schools and worksites or laboratory-confirmed influenza in residential institutions occurring in greater than or equal to 50% of the influenza surveillance region(s)

* Confirmation of influenza within the surveillance region at any time within the prior four weeks

† Sub-regions within the province or territory as defined by the provincial/territorial epidemiologist

Influenza-Like Illness (ILI) Definitions:

A) ILI in the general population:

Acute onset of respiratory illness with fever and cough and with one or more of the following - sore throat, arthralgia, myalgia, or prostration which could be due to influenza virus. In children under 5, gastrointestinal symptoms may also be present. In patients under 5 or 65 and older, fever may not be prominent.

B) ILI/Influenza outbreaks:

Schools and work sites: greater than 10% absenteeism on any day most likely due to ILI **Residential institutions:** two or more cases of ILI within a seven-day period, including at least one laboratory-confirmed case.
