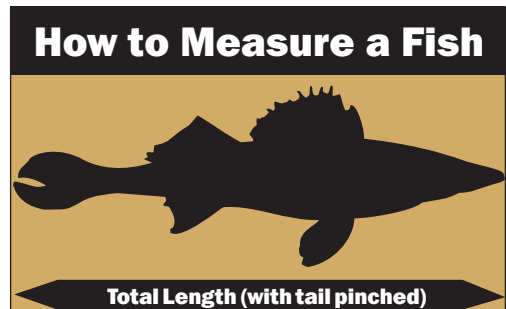
Their Future is in Our Hands

This award recognizes conservation efforts of anglers who catch and release memorable fish.

Rules and Regulations

1. All anglers fishing in Saskatchewan are eligible to apply.
2. Fish must be legally angled within the province.
3. To qualify, a fish must be one of the listed species and meet the minimum size requirements. Fish should be measured from the tip of the snout to the tip of the tail when pinched (see diagram and table).
4. Fish that does not survive when released are not eligible. Refer to the "Catch and Release" section in the Anglers' Guide for proper handling and methods.
5. Each qualifying fish must be submitted on a separate form. If fishing alone, the witness verification may be omitted. Otherwise, all sections must be completed.
6. Application forms must be received by April 15th of each year.
7. Applicants who meet requirements will be awarded a conservation certificate.
8. Department representatives are the final judge of all applications, and reserve the right to publish names and addresses of award recipients.
