#### **Act Amendments**

The following amendments to *The Securities Act, 1988* will come into force on March 17, 2008:

- these new sections will be added:
  - o new section 60.1, respecting the power of the Director to impose terms, conditions, or restrictions on a prospectus receipt is added;
  - o new section 80.01 "Revocation of purchase"
- these provisions will be repealed:
  - o section 62 "Amendment to preliminary prospectus on material change"
  - o section 63 "Amendment to prospectus on material change"
  - o section 64 "Receipt for amendment"
  - o section 65 "Certificate of statement of rights"
  - o section 66 "Certificate by issuer for distribution"
  - o section 67 "Certificate of underwriter"
  - o section 68 "Alternative certificates"
  - o section 69 "Statement of rights"
  - o section 71"Refiling of prospectus"
  - o section 74 "Distribution of preliminary prospectus"
  - o section 75 "Distribution list"
  - o section 80 "Obligation to deliver amended prospectus"
- these provisions will be amended:
  - o section 70 "Receipt for prospectus"
  - o section 76 "Defective preliminary prospectus"
  - o section 78 "Order to cease trading"

# **Regulation Amendments**

The following amendments to *The Securities Regulations* will come into force on March 17, 2008:

- the definitions of "debt security", "finance company" and "industrial company" in subsection 2(1) will be repealed;
- all of Part VII "Prospectus Distribution" will be repealed; and
- the following forms will be repealed:
  - o 13 Information Required in Prospectus of Industrial Company
  - o 14 Information Required in Prospectus of Finance Company
  - o 15 Information Required in Prospectus of Natural Resource Company
  - o 16 Information Required in Prospectus of a Mutual Fund, and
  - o 18.1 Material Change Report Pursuant to Section 80.1 of the Act.

### **Saskatchewan Instruments**

Effective March 17, 2008 the following local instruments will be repealed:

- Saskatchewan Instrument 46-501 Disclosure of Cash Calls; and
- Saskatchewan Instrument 47-501 *Marketing Communications*.

The Commission will amend Saskatchewan Local Policy Statement 43-201 *Unconscionable Consideration – Promoters* effective March 17, 2008.

The Director will repeal the following General Rulings/Orders ("GROs") effective March 17, 2008:

- GRO 44-801 Implementing National Instrument 44-101 Short Form Prospectus Distributions;
- GRO 44-802 Implementing National Instrument 44-102 Shelf Distributions; and
- GRO 44-803 Implementing National Instrument 44-103 Post-Receipt Pricing.
- Order 41-901 *Use of Prospectus Complying with OSC Rule 41-501 Prospectus Requirements*
