CHAPTER C-45.1 REG 1

The Credit Union Act, 1985

Title

1 These regulations may be cited as *The Credit Union Regulations*.

Interpretation

- 2 In these regulations:
 - (a) "Act" means The Credit Union Act, 1985;
 - (b) "affiliate" means, with respect to a credit union, a corporation or cooperative in which the credit union owns or controls 10% of the securities of the corporation or co-operative that give the right to vote or the residual right to participate in the earnings of the corporation or co-operative and its assets on liquidation or winding up;
 - (c) "document" means a report, return or other document required to be sent to the registrar pursuant to the Act or these regulations;
 - (d) "form" means a form as set out in Part VI of the Appendix;
 - (e) "lawful money of Canada" means:
 - (i) coins with a face value of two dollars or less that are current within the meaning of the *Currency and Exchange Act* (Canada), as amended from to time; and
 - (ii) Bank of Canada notes issued pursuant to the *Bank of Canada Act*, as amended from time to time.

Fees

- **30**(1) Subject to subsections (2) and (3), when a credit union has a service provided by the registrar, it shall pay the fee prescribed in Table 2 of Part I of the Appendix.
- (2) Where the registrar considers it to be appropriate, he may waive payment by a credit union of any of the fees prescribed in Table 2 of Part I of the Appendix for a service he has performed.
- (3) Only one fee pursuant to item (r) in Table 2 of Part 1 of the Appendix or a comparable provision of The Business Corporations Regulations, The Business Names Registration Regulations, The Co-operatives Regulations, 1989, The Names of Homes Regulations or Saskatchewan Regulations 260/79 made pursuant to The Non-profit Corporations Act shall be charged where a report is prepared that includes names registered pursuant to The Business Corporations Act, The Business Names Registration Act, The Co-operatives Act, 1989, The Names of Homes Act or The Non-profit Corporations Act in addition to names registered pursuant to the Act.
