

# FILING ARTICLES OF CONTINUANCE Under The Corporations Act of Manitoba



If an extra-provincial or federal corporation wants to become a Manitoba corporation, it must file ARTICLES OF CONTINUANCE by following these steps:

## STEP 1: RESERVING THE NAME

This step must be done only if the corporation is **not** already registered under the Manitoba Corporations Act.

### Form Required

### Filing Fee

Request for Name Reservation

\$40.00

In addition to the traditional paper application that is still available, a Request for Name Reservation can be filed online at <https://direct.gov.mb.ca/coohtml/html/internet/en/coo.html>.

If your name is **reserved**, you will have 90 days to file the Articles of Continuance forms by following Step 2 below. If your name is **rejected**, you must choose a new name and do Step 1 over again (including fee).

## STEP 2: FILING ARTICLES OF CONTINUANCE

A valid **Approval to Continue** must be obtained from its home jurisdiction.

## DO YOU HAVE A BUSINESS NUMBER?

A Business Number (BN) is assigned by Canada Revenue Agency. If you already have a Business Number (BN), it is very important that you provide it. If you do not have a BN already, Companies Office will obtain one for you.

## NOTICE UNDER THE FREEDOM OF INFORMATION AND PROTECTION OF PRIVACY ACT

Information about this corporation is collected pursuant to *The Corporations Act*. It is made available for public searching pursuant to that Act. ## Special Notes

- All forms must be typed or printed clearly and signed in ink.
- You will have to give us an extract (and/or legal opinion) that the home jurisdiction permits the continuance. This is not needed if the corporation is continuing from Alberta, British Columbia, Ontario, Saskatchewan or the Canada Corporations Act.
- You should see a lawyer if you have any legal questions about filing Articles of Continuance.

**PAYMENT OPTIONS**

If you are filing the Name Reservation (paper applications only) and Articles of Continuance forms together:

- If paying by **cheque**, please ensure there are two separate cheques (or **money orders**), payable to the **Minister of Finance**.  
If not, the office cannot process your forms and will need to send everything back.
- If paying by **credit card**, your signature on this form authorizes us to process two separate transactions.
