

# 2007 Assessment Rates

In 2007, newly registered firms are normally assigned the following rates according to their industry. Once a firm has been registered for a year, it can then be "experience rated." This means that the firm will be assigned a rate according to its injury costs, subject to the rate range for their industry.
