

Aging in Place is a matter of preserving the ability for Manitobans from every culture to remain safely in their own community, to enjoy the familiar social, cultural and spiritual interactions that enrich their lives even though their health may be compromised.

Aging in Place supports an individual's identity and sense of self within the larger community, whether it is in rural or urban areas, in northern or aboriginal communities.


The principles of *Aging in Place* addresses the need for affordable options for housing with supports, as alternatives to premature personal care home placement. The strategy addresses the elements between an individual living in their home and Personal Care Homes.

Aging in Place is a lifestyle that supports the following inherent values:

- Safety and security living with reduced risks in the home;
- Flexibility adjusting services to meet changing needs;
- Choice freedom to choose among options;
- Equity equal access for all seniors;
- Dignity Ability to maintain sense of self worth, self esteem and humanness

It is anticipated that supporting individuals to remain in their community and "age in place" will not only promote independence in daily living, but will also maximize overall well being and health.

FEDERAL INCOME SECURITY PROGRAMS

Canada's public pension system provides seniors with a secure, modest base of retirement income. The two main programs are Old Age Security and the Canada Pension Plan. Benefits offered by these programs do not start automatically – you must apply for them.

OLD AGE SECURITY (OAS)

If you are 65 or older and meet the Canadian residence requirements, you are entitled to the Old Age Security Pension. You should apply at least six months before you turn 65. If you lived in Canada, but now live in another country, you may still be eligible. Full or partial pensions are determined by the length of residency in Canada.

Old Age Security application packages can be obtained by calling the toll-free number or by visiting your local Human Resource Centre.

GUARANTEED INCOME SUPPLEMENT (GIS)

The federal government program ensures that every senior has a guaranteed minimum income. The GIS is an additional monthly benefit available to seniors who receive an Old Age Security pension and have a low income.

First time applicants can receive an application form by calling the toll-free number or by visiting your local Human Resource Centre. If you file your income tax return every year on time you will not need to reapply. The GIS is not a taxable income.

THE ALLOWANCE

If you are between 60 and 64 and your spouse or common-law partner is an OAS pensioner who is eligible for the GIS, you may qualify for the Allowance. The Allowance:

• is a monthly benefit that helps bridge the income gap until you turn 65

- is not a taxable income
- will continue upon death of the pensioner, based on the survivor's income, until age 65
- must be re-applied for annually

ALLOWANCE FOR THE SURVIVOR

If you are between 60 and 64, have a low income, and your spouse or common-law partner has died, you may qualify for the Allowance For The Survivor. The Allowance For The Survivor is not a taxable income.

CANADA PENSION PLAN (CPP)

RETIREMENT PENSIONS

Most working Canadians contribute to the Canada Pension Plan. If you have contributed to the Plan, you are entitled to a retirement pension.

CPP is a monthly payment to individuals who are at least 60 years of age. The amount you receive is based on how much and for how long you contributed to the Plan. It is also affected by what age you take your pension. For example, if you take your pension before the age of 65, your benefits will be reduced.

You must apply for these benefits. You should apply at least six months before you want to receive them.

If you contributed enough to the CPP you or your family may be eligible for the following other Canada Pension Plan Benefits:

SURVIVOR BENEFIT

If you die, your surviving spouse or commonlaw partner and dependent children may be eligible for a monthly survivor benefit.

DEATH BENEFIT

If your spouse or common-law partner dies, you may be eligible for a lump sum death benefit to help with the costs of the funeral.

DISABILITY PENSION

If you have a disability which prevents you from working, you may be eligible for a monthly disability benefit. These benefits are converted to retirement pensions at age 65.

PENSION SHARING

If you are married or in a common-law relationship, you may be able to save on income tax by pension sharing. If you and your spouse/common-law partner are both at least 60, you can apply to share your CPP retirement pensions equally. Both must be at least 60 and have applied for any CPP pensions to which they are entitled.

CREDIT SPLITTING

If you are separated or divorced, CPP contributions made by you or your spouse/common-law partner can be divided equally. This division applies to contributions you both made during your marriage or common-law relationship. You may be entitled to retirement, disability, or other benefits higher than those for which you would qualify on your own.

CANADA PENSION PLAN SUMMARY

- You must apply for all benefits and programs.
- All benefits are considered taxable income.
- A cost-of-living adjustment is made in January of each year.

ROYAL CANADIAN NAVAL BENEVOLENT FUND

The Royal Canadian Naval Benevolent Fund (RCNBF) helps relieve distress caused by illness, accident or other misfortunes. The fund provides interest-free loans or grants to veterans and ex-service personnel in need of financial assistance. To be eligible you must be a former member of the Naval Forces of Canada who entered prior to February 1, 1968, and the Canadian Merchant Navy War Veterans, and those entered after 1 February, 1968 who were posted with the Maritime Command or carry the distinguishing Navy rank or sea designation, on their release, shall be considered to be ex-members of The Naval Forces of Canada, and the dependants of the above.

The Fund has helped people buy necessities such as food and clothing, and pay for medical, dental, optical, surgical and prosthetic services. It also provides assistance for necessary home repairs and funeral costs, and to replace belongings destroyed by fire. PROVINCIAL INCOME SECURITY PROGRAMS

FIFTY-FIVE PLUS — A MANITOBA INCOME SUPPLEMENT

You may be eligible for an income supplement if you have a low income and are 55 and over.

If you:

DO NOT RECEIVE benefits under the Federal Old Age Security Program, you must apply for 55 PLUS for each benefit year. You may apply at any time during the benefit year. Your benefits begin in the quarter in which your completed application is received. If you are married and your spouse is either under 55 or over 65, you may still be eligible for 55 PLUS benefits. An application will be required.

If you:

RECEIVE benefits from the Federal Old Age Security Program; you are not required to apply. Your eligibility is automatically determined by the level of benefits you receive from the Guaranteed Income Supplement, Allowance, or Allowance For The Survivor. For more information, contact:

OTHER TAX CREDITS

These tax credits can be applied for each year by filling out your Income Tax form.

EDUCATION PROPERTY TAX CREDIT (INCOME TAX FORM MB479)

The educational Property Tax Credit provides a credit to homeowners and tenants who pay at least a specified amount in property taxes regardless of age or income. There is additional tax relief for seniors who meet the qualifying income criteria.

THE PERSONAL TAX CREDIT (INCOME TAX FORM MB 479)

The personal Tax Credit is a refundable credit. In addition to the basic amount, taxpayers age 65 and over may claim an additional amount for themselves and a dependant spouse age 65 and over.

MANITOBA FAMILY TAX REDUCTION (INCOME TAX FORM MB428)

The Manitoba Family Tax Reduction reduces Manitoba tax payable. In addition to the basic credit, taxpayers 65 and over may claim an additional amount for themselves and a dependant spouse age 65 and over.

SCHOOL TAX CREDIT FOR HOMEOWNERS/ TENANTS (MB INCOME TAX FORM 479)

- Homeowners apply on the indicated income tax form
- Tenants must contact Manitoba Housing

This program provides non-taxable benefits seniors 55+, towards school taxes payable on a homeowner's principal residence, or toward the school tax portion of rental costs for tenants.

PENSION INCOME AMOUNT (INCOME TAX FORM MB428)

Manitoba Taxpayers are eligible to claim a specified amount if they receive pension or annuity income.

INCOME TAX SERVICES

Information is provided at the Manitoba Tax Assistance Office in Winnipeg to help complete the provincial section of the tax return.

Many senior centres across the province offer special clinics for income tax preparation, including Age & Opportunity and the Manitoba Society of Seniors.

HOW TO APPLY FOR BENEFITS

PROOF OF AGE

To obtain reductions and benefits available to older adults, you are often expected to prove your age. This is especially important when you are applying for government pensions and benefits. A copy of your birth or baptismal certificate should be included with your application form. If you do not have either forms of identification, other documents are often accepted.

SOCIAL INSURANCE NUMBER

Any government application requests that you have a social insurance number. Application forms are available at all post offices and Human Resource Centres.

Other Acceptable Documents:

Usually, two or more of the following are required:

- family Bible or other personally kept family records;
- marriage certificate, church roll, communion or confirmation certificates;
- education documents such as school registers, diplomas, teacher's certificates;
- insurance record of government annuity contract;
- hospital or medical records, vaccination records;
- pension or superannuation records;
- employment records;
- newspaper clippings;

- public records such as assessment rolls, voter and jury lists;
- membership records in lodges, clubs and associations;
- military records;
- court records;
- census records and national registration records;
- naturalization documents, citizenship certificate, immigration record or passport.

Community Financial Counselling Service provides financial assessment, credit counselling and information on money management to individuals and families. A new partnership with Addictions Foundation of Manitoba provides for gambling counselling as well.

APARTMENT RENTAL OPTIONS

SUBSIDIZED HOUSING

If you are 55 years of age or older and have a low income you may be eligible for subsidized housing provided by the Manitoba Housing Authority (MHA). Your rent will be based on your total gross income.

For example: One Person = Studio Apartment =

25% of gross income

Two Persons (couple) = One Bedroom =

27% of gross income

In the rural communities, some seniors' buildings may only have one bedroom available. In this case, single persons would receive a one-bedroom apartment.

There are eligibility requirements with the highest priority given to those identified as most in need.

Some MHA senior buildings offer tenants additional services. Please ask your MHA office in your community if these services are available:

 medical alarm switches located in tenants' apartments which provide 24-hour service for emergency alert purposes only.

- a congregate meal program located on-site.
- tenant services staff.
- on site building superintendants.

PRIVATE NON-PROFIT HOUSING

This is rental accommodation that is owned and managed by charitable or non-profit organizations such as service clubs or church groups. Restrictions regarding tenant eligibility, rent levels and available subsidies differ depending on the project.

CO-OPERATIVE HOUSING

Co-operative housing is owned by notfor-profit community groups who have incorporated to provide housing for their members. Co-op members purchase equity shares in the project and collectively become owners of the building. Subsidies may be available to low-income members. Persons wishing to become tenants in an existing project must purchase a share in the co-op.

ASSISTED LIVING FACILITIES

Assisted Living facilities offer independent living in a service package. Facilities are **not licensed or government regulated**. Look at your contract very carefully to know what are guaranteed services and what are non-guaranteed services. Government does not subsidize daily fees, but residents may qualify for Manitoba Shelter Benefit Program.

Examples of services provided may include:

- meals
- housekeeping

- laundry
- transportation
- · financial management

LIFE LEASE TENANCY

Life lease is a unique tenancy agreement where the tenant pays an entrance fee for the rental unit and may remain a tenant for life or a certain period of time.

Monthly rent depends on the size of the mortgage on the building, maintenance costs, taxes and vacancy rates.

The Life Leases Act of the Province of Manitoba controls life lease agreements. For complete information contact the Residential Tenancies Branch.

People considering this type of housing should review the financial health of the project and talk to a lawyer to fully understand the terms of the life lease agreement.

COMMERCIAL HOUSING

The private market offers an increasing variety of housing for seniors, ranging from conventional apartments and condominiums for a mixture of ages and income levels, to projects designed especially for seniors. Some provide amenities such as fitness facilities and swimming pools, and some provide services such as cleaning, transportation and dining facilities.

Low-income seniors renting in the private market may be eligible for cash assistance under the Shelter Benefit Program.

HOME IMPROVEMENT ASSISTANCE

RESIDENTIAL REHABILITATION ASSISTANCE PROGRAM (RRAP)

The Homeowner Residential Rehabilitation Assistance Program (RRAP) is a federal/provincial cost shared program that provides financial assistance to low-income owners of existing rural and urban housing. Housing must need major repair in either: structural, electrical, plumbing, heating or health and safety. The nature and quality of the repair work is expected to further the useful life of the dwelling by at least 15 years.

Similar assistance is available under RRAP for Persons with Disabilities for alterations required to accommodate the needs of a disabled occupant. The alterations must be related to the dwelling and the occupant's disability and must be permanent. Household income determines client eligibility.

HOME ADAPTATIONS FOR SENIOR'S INDEPENDENCE (HASI)

HASI, a federal/provincial cost shared program, helps low-income seniors who have difficulties with daily living and activities in the home, by providing financial assistance to homeowners and landlords to carry out minor home adaptations that accommodate age related disabilities.

Items such as handrails in hallways and on stairs, easy-to-reach work and storage areas in the kitchen, lever handles on doors, walk-in showers with grab bars, and bathtub grab bars and seats are examples of adaptations that can be made. Assistance in the form of a forgivable loan of up to \$3,500 is available.

HOMEOWNER EMERGENCY LOAN PROGRAM (HELP)

This provincial government program is designed to help low-income homeowners improve their housing conditions. Interest-free loans to a maximum of \$3,000 are available. Repairs must be of an urgent nature and pose a threat to the health and safety of the occupants to qualify.

EMERGENCY REPAIR PROGRAM (ERP)

The Emergency Repair Program (ERP) is a federal/provincial cost shared program that assists eligible low-income homeowners or occupiers in rural and remote areas to undertake emergency repairs for the continued safe

occupancy of their houses. It targets homes in communities of 2,500 or less. Assistance is in the form of a forgivable loan. Income, location and the nature of repair determine eligibility and amount of the loan.

THE MANITOBA HOME CARE PROGRAM

The Manitoba Home Care Program provides home health care services. Services can be requested by you (as an individual), your family or by your doctor. It provides supports or services to assist you to remain independently and at home for as long as safely possible.

Once Home Care receives a request for service, a Home Care Case Coordinator will meet you and any other caregivers at home to discuss your care needs. Based on the information gathered, the coordinator develops a care plan to help you manage at home for as long as is practical.

If other services are needed, you can access long-term care and housing options through

the Home Care Program. You or your family member can request information from your Home Care Case Coordinator at any time.

The range of services provided by Home Care include

- personal care
- home support
- nursing, respite/caregiver relief
- occupational and physical therapy assessments
- household maintenance
- referrals to other agencies
- adult day programs
- service coordination and assessments for long-term care and specialty services

If you become ill and are admitted to hospital, the hospital will inform the Home Care Program and a plan is made for when you return home. If you cannot return home, the Case Coordinator can help you access appropriate housing and care options such as supportive housing, companion care, personal care homes or chronic care hospital placement.

HOME CARE APPEAL PANEL

If you have concerns about your home care, first talk to your home care case coordinator or his/her supervisor. If you are still not satisfied, you may file an appeal with the Appeal Panel for Home Care. This panel hears appeals from people who have asked for home care services and who disagree with the decisions made about their eligibility or their level of service.

You may file an appeal if:

- your request for home care service was turned down.
- you disagree with the level of service you receive.
- you have any concerns about the home care services you are receiving.

RESIDENTIAL CARE

Residential care is a community-based housing option that provides congregate living accommodations with care and supervision at levels defined by Manitoba Family Services and Housing.

Residential care facilities are licensed through Manitoba Family Services and Housing. Facilities may be profit or non-profit and operated by professional or non-professional staff. The Manitoba government does not subsidize residential care; however, you may qualify for financial assistance under the Manitoba Shelter Benefit (MSB) Program. PERSONAL CARE HOME PLACEMENT

A personal care home may be the most appropriate care setting when your care needs can no longer be managed within your home or an alternative community setting.

To apply for personal care home placement, contact your:

- Home Care Case Coordinator or
- Regional Health Authority for more information if you are not receiving Home Care

Eligibility:

- Canadian citizens and permanent residents who have lived in Manitoba for the previous five consecutive years are eligible for insured personal care home services.
- If you are a new Canadian citizen or a new resident to Manitoba, you should discuss your eligibility with your Home Care Case Coordinator as restrictions may apply.

Assessment:

Applications are reviewed by an assessment panel to decide on the most appropriate environment where care needs can be met. If your application is denied, you may reapply and be reassessed at a later date if care needs change.

There may be a waiting period before you are admitted to the personal care home of your choice. During this time, home care services may be provided to you as necessary.

If you require admission immediately, or are in hospital awaiting placement, you may be asked to accept placement in a different care facility until you can be admitted to the personal care home of your choice.

RESIDENTIAL CHARGES AT PERSONAL CARE HOMES

The cost of personal care home services is shared by the provincial government (Manitoba Health) and the client who needs the services. Manitoba Health pays the majority of the cost through the Regional Health Authorities and the client pays a residential charge.

The residential charge paid by a client is based on income. The rate structure ensures that all clients have a reasonable amount of spending money for personal expenses after paying the residential charge.

The initial charge assessed for each client is the maximum daily rate. You may apply for a reduction to the maximum rate by completing a Tax Information Release Form, or by completing an Application for Reduced Residential Charges and providing a copy of your Canada Revenue Agency Notice of Assessment from the previous year. Facility staff will give you the correct form(s).

You may request a review or appeal the assessed rate within 30 days of the effective date of the charge. A Request for Review/ Appeal form is available at the facility. Facility staff will advise you of the review/appeal process and provide you with the form.

THE PROTECTION FOR PERSONS IN CARE OFFICE

PHARMACARE PROGRAM

Pharmacare is a drug benefit program for all Manitobans whose income is seriously affected by high prescription drug costs. Pharmacare coverage is based on total family income and the amount you pay for eligible prescription drugs.

Each year you are required to pay a portion of the cost of your eligible prescription drugs. This portion is referred to as the **Pharmacare deductible**. Your deductible is based on your total family income.

In 2000, Manitoba residents were provided with the option of applying to the Pharmacare Program through a one-time enrolment process or annually.

Manitobans who selected the one-time enrolment process (Option A) are no longer required to annually submit a Pharmacare Application.

36 Manitoba Seniors' Guide

Manitoba Health will establish the Pharmacare deductible for April 1 of each benefit year. Shortly after the beginning of each benefit year, Manitobans who selected this option will receive a letter from Manitoba Health confirming their enrolment and deductible level.

In order to be eligible for benefits, Manitobans who chose the annual application process (Option B) must complete a Pharmacare Application and Consent Authorization within each benefit year, April 1 to March 31. Applicants must also include a copy of the Revenue Canada Notice of Assessment from the taxation year 2 years prior to the beginning of the benefit year with their completed application.

The deadline for filing your 2007/2008 Pharmacare Application is March 31, 2008.

EYEGLASS PROGRAM

The Eyeglass Program provides limited financial assistance toward the purchase of eyeglasses for Manitoba residents 65 years of age and older (one pair of eyeglasses every three year period – or more often if there is a change in vision).

The total allowable amount is based on a fixed schedule for dispensing fees, frames and lenses. You are required to pay a \$50 deductible and

Manitoba Health will pay 80 per cent of the remainder. The amount payable is based on a fixed schedule and not based on the total cost of the eyeglasses.

The \$50 deductible applies once a year (April 1 to March 31) per family. If additional glasses are required within the 12 month period, you do not have to pay the deductible again. Claim forms are available from optometrists and opticians. For more information, contact:



Complaints which are not resolved may be referred to an independent human rights adjudicator, who is appointed by the Attorney General of Manitoba, for a hearing.

The Commission balances its enforcement activities with the promotion of human rights and public education. It conducts public education programs, and has developed a series of workshops and seminars on human rights topics. It also publishes The Manitoba Human Rights Connections Bulletin once a month. SOCIAL SERVICES APPEAL BOARD

The Social Services Appeal Board is an independent appeal board for decisions regarding provincial income assistance and other programs offered by Manitoba Family Services and Housing, including 55 Plus – A Manitoba Income Supplement Program.

You may file an appeal if you are in receipt of, or are applying for, certain provincial assistance programs and if you have had your benefits denied, suspended or reduced. The appeal is as follows:

- send a letter of appeal to the Board or by completing an appeal form, which is available on request.
- the appeal must be filed within 30 days of being notified of the decision to deny, reduce or suspend benefits.
- once filed, a hearing will be scheduled within 30 days and both parties will be given the opportunity to explain their case directly to the Board.
- a decision is then made in private after the hearing.
- a letter is then sent, usually within 15 days of the hearing, advising of the decision.

In Winnipeg, services are divided into speciality units. The type of crime determines which unit will assist the victim.

In rural Manitoba, crime victim service workers provide a range of services to victims in each of the above categories of crime.

Specific Programs:

Victim Rights Support Service

The *Victims' Bill of Rights (VBR)* came into effect in 2001. This legislation specifies the rights of victims of the most serious crimes. The bill ensures crime victims' rights are recognized

and protected in their dealings with police, prosecutors, courts and corrections officials.

Victim Rights Support Service assists victims who qualify for services under this legislation by:

- helping them register for their rights under VBR
- explaining when and how they may exercise their rights
- providing information about the prosecution and results of the case against the accused
- providing court support and information, when possible

Domestic Violence Support Service Domestic Violence Support Service helps victims of domestic violence when criminal charges have been laid, or may be laid against their partners. The program provides support and information

to victims of domestic violence by:

- providing information about the criminal charges and the court process
- explaining the roles of those involved in the criminal justice system
- discussing safety planning
- explaining how to get protective relief orders
- offering on-going emotional support and short-term counselling
- explaining the cycle of violence and how it can be broken
- offering support throughout the court process
- providing court preparation and going to court with victims, when possible
- advising the Crown attorney of concerns victims may have about court cases
- providing information and referrals to community resources, as needed

The program also provides victims with information about the Cell Phone Emergency Limited Link-up/Short Term Program (CELL).

Cell Phone Emergency Limited Link-up Program (CELL)

The CELL program gives an added level of protection to people who are involved in high

risk relationships or stalking. The program is a co-operative effort between MTSTM, NokiaTM, social service agencies, police services and Manitoba Justice. It is available in several Manitoba communities.

The program loans victims free cell phones at times of extreme risk. The phones are pre-programmed to dial emergency services. Victims of domestic violence or stalking who receive the phones must have a written protection plan in place.

Child Victim Support Service (CVSS)

The Child Victim Support Service (CVSS) helps victims and witnesses of abuse (up to 18 years of age), adult survivors of sexual abuse, and other vulnerable victims (on a case by case basis) who are involved in the criminal court process. They reduce fear and help victims and witnesses cope by:

- explaining the criminal court process and procedures
- preparing them for court (including a visit to the courtroom to help familiarize witnesses with their surroundings and make them feel more comfortable)
- identifying special needs and the potential for aids to help with testimony
- attending court with witnesses, when possible
- scheduling meetings with Crown attorneys to discuss any special issues
- arranging short-term counselling for victims, witnesses and their caregiver(s)
- providing emotional support to witnesses and their caregiver(s)
- referring victims to community resources such as therapists or treatment programs
- providing information and guidance on how to prepare Victim Impact Statements

Compensation for Victims of Crime Program The Compensation for Victims of Crime program provides compensation to victims who suffer personal injury, hardships or expenses as a result of certain crimes. The program is also available to specific relatives and dependants of victims of homicide in Manitoba.

If someone has been injured as a result of a crime, or someone is an immediate family member of a person killed due to a crime, that person may be entitled to compensation. People may also be compensated if they were injured while helping a police officer or while trying to prevent a crime.

To apply for compensation, the offender does not need to have been caught, but a formal report must be made to the police.

Compensation may cover reasonable expenses (not already covered by another source) resulting from a crime including:

- payment of medical expenses (prescription drug costs, ambulance bills)
- replacement of damaged clothing or items seized by police as evidence
- dental treatment, replacement or repair of dentures
- replacement or repair of prescription eyeglasses
- payment for grief therapy or other counselling services
- compensation for lost wages for victims who have been disabled or for dependants of a victim who was fatally injured
- support payments for dependents
- payment for rehabilitation or retraining
- compensation for permanent disability
- payment of funeral expenses

poenaed to appear in either Provincial Court or Court of Queen's Bench in Winnipeg.

Services to victims include:

- written correspondence with the Crown attorney about their specific case concerns
- information and guidance on how to prepare Victim Impact Statements
- court preparation
- · accompaniment to court
- court cancellation notifications
- reimbursement of expense claims

Domestic Violence Intervention Unit

The Domestic Violence Intervention Unit offers support to families who receive police services for domestic violence incidents that occur in Winnipeg, but that do not result in charges or arrests. Specially trained workers help people at risk of abuse in relationships to stop the cycle of violence.

Services include:

- creating a safe, supportive environment to talk about the situation
- connecting families to appropriate community resources through information referral, advocacy and co-ordination of community resources
- providing short-term emotional support and referral to counselling
- creating a protection plan to improve safety
- offering information about and help with orders of protection
- providing service to both partners where it is appropriate and safe to do so

The Manitoba Shelter Benefit

(Formerly known as SAFER/SAFFR)

Helping low-income families, seniors and persons with disabilities pay the rent

The Manitoba Shelter Benefit is a monthly benefit that helps low income seniors, families and persons with disabilities pay their rent. Created in 2006, the Manitoba Shelter Benefit replaced the Shelter Assistance for Elderly Renters (SAFER) and Shelter Assistance for Family Renters (SAFFR) programs.

What's new

Renters under 55, who have a disability, have a spouse or common-law partner with a disability or, have an adult dependent with a disability living at home, may be eligible to receive the Manitoba Shelter Benefit.

Who it's for

If you're not already receiving this benefit, it is available to the following renters living in private rental accommodations:

- single renters over 55
- couples where one person is over 55
- renters under 55 with one or more dependents under 18
- renters under 55, who have a disability, have a spouse or common-law partner with a disability or, have an adult dependent with a disability living at home

You may also be able to receive a benefit if you are living in private rental accommodations and you are a person with a disability who receives Employment and Income Assistance (EIA). You don't need to apply—EIA will let you know if you are eligible.

How it works

If you live in private rental accommodation you may be eligible to receive a maximum monthly benefit of \$200. per month. However, the amount you receive is dependent on your total family income and your monthly rent.

You are not eligible to receive the Manitoba Shelter Benefit if you already rent your home from the Manitoba Housing Authority or if you already receive another type of housing benefit.

For those who still need the level of care provided in a personal care home, significant efforts are underway to create more single-bed rooms that will improve the living environments of residents.



TALKING WITH YOUR DOCTOR



Become an active participant in your own health care. People who talk with their doctor feel more comfortable about their treatment plans and educated about their health issues. You and your doctor are partners, working together to ensure your good health.

The following is a list of tips that you can use for talking with your doctor.

GIVE YOUR DOCTOR INFORMATION.

- Provide your doctor with as much information as possible about symptoms and your healthy history, even if it makes you feel embarrassed. This will allow your doctor to make the best decision about your care. Prepare a list before hand of symptoms that you are experiencing.
- Remember to bring a list of medications and herbal remedies along with you (include the name, dose and when you take the medication). While reviewing your medication list, don't forget to tell your doctor about any reactions or side effects you may be experiencing.

GET INFORMATION FROM YOUR DOCTOR.

- Ask your doctor questions. Prepare a list with the most important questions first so that the doctor is able to answer them. Write down the answers or ask your doctor to put his/her instructions in writing.
- Take notes during your visit so you can refer to them later.
- If you don't understand, ask more questions and repeat what you think the doctor has said.
- Ask your doctor if there are any activities you should be avoiding due to your medical condition or medication.
- If you feel uncomfortable asking questions, bring a person you trust to your appointment who can do it for you.



TALKING WITH YOUR DOCTOR

- Ask your doctor questions about medical tests such as how long it will take for the test results and when you should contact the office for the results.
- If you need more time for your visit, let your doctor know. If your doctor is not available ask if you can speak with another health care professional.
- Ask your pharmacist. Pharmacists can provide you with additional information on medicines and health care products.

TAKE YOUR INFORMATION HOME.

 Ask your doctor for pamphlets or educational materials related to your medical condition. If your doctor doesn't have any, ask him/her where you can get some additional information.



 Call your doctor if you have additional questions about your treatment, symptoms you may be experiencing or prescribed medications.

FOLLOW UP.

- If required, call to schedule your medical tests or follow up appointments (doctor and/or specialist).
- If your symptoms get worse call your doctor immediately or seek medical attention.

UPDATE YOUR EMERGENCY RESPONSE INFORMATION KIT (E.R.I.K.).

- By filling out and updating each form on a regular basis, paramedics and other health care professionals are able to provide focused service in an emergency.
 The Emergency Response Information Kit contains an information brochure, a Health Information Form, a Health Care Directive Information sheet and form, an organ donation card and a sticker for the front door of your residence.
- Place your Emergency Response
 Information Kit on the fridge so that
 emergency response personnel are able to
 locate the kit in the event of an emergency.

INFORMATION FOR CAREGIVERS

Caregivers play an important and invaluable role in our society by allowing people to remain living in their family homes as long as possible.

Caregiving has many positive benefits, such as:

- A renewed relationship with the person being cared for
- New relationships with others through support groups and community services
- A chance to give back
- A sense of accomplishment
- An opportunity to develop new abilities, knowledge, i.e. advocacy skills
- Growth and increased overall compassion for others
- A heightened sense of value and self esteem

While there are many rewards associated with caregiving, there are also some challenges to keep in mind. The following are some common challenges and helpful hints to keep in mind when caring for another person:

 Caregivers don't have to be all things to all people. Involve other family members and friends in order to build a strong support system. In addition, turn to health care professionals and your community for help and support when needed.

- When a family member can no longer live safely alone at home, he/she may resist change. Respect and recognize the impact these changes will have on the individual. Caregivers who recognize that their loved one is not a child are better prepared to care for an increasingly dependent person. Include the individual cared for in any discussions and decisions in order to maintain a sense of independence and dignity at times of change.
- Negative attitudes towards physical/ mental changes are normal. It is upsetting to watch a loved one experience physical





- and or mental decline. But keep in mind that people all experience physical changes as they age. Some of them may also experience mental changes. Certain changes are reversible; others are not.
- Respite care provides the caregiver with a break from caregiving responsibilities and is available through formal organizations or short term placement in a personal care home. Respite care should be used regularly in order to prevent burnout. Remember, strive for balance not perfection.
- When faced with a difficult situation, speak up!
 - I. In the event that the caregiver and the family member develop any form of conflict with the assigned aide/volunteer/nurse/companion, feel free to contact the home care coordinator, agency or organization. Explain the situation in detail and work together to formulate alternatives which will provide the best outcome for all parties involved.
 - II. If you have concerns regarding the quality of care being provided at a personal care home, address your concerns with the charge nurse or administrator. Follow up on a regular basis and keep track of any changes made by the facility.

- When making decisions for a loved one who is no longer mentally alert, the caregiver should involve other family members as much as possible. However, if you reach a deadlock, don't give up. Focus on what is best for the individual and try to reach a mutual agreement. Be open to compromise.
- Take care of your own health. Try to get good nutrition, sufficient exercise and adequate rest (think of rest as recharging, not as being lazy). Also, maintain hobbies and interests you enjoy.

Health Care Directives in Manitoba

What is the purpose of a Health Care Directive?

As a Manitoba citizen you have the right to accept or refuse medical treatment at any time. The *Health Care Directives Act* allows you to express your wishes about the amount and type of health care and treatment you want to receive should you become unable to speak or otherwise communicate this yourself. It also allows you to give another person the power to make medical decisions for you should you ever be unable to make them yourself.

Why should I fill out a form?

Due to accident or illness, you may become unable to say or show what treatment you would like, and under what conditions. If you have signed a directive, those close to you and the health care professionals treating you are relieved of the burden of guessing what your wishes might be.

How do I make a Health Care Directive?

The Manitoba government has prepared a form for your convenience (see reverse). The form serves as a guide for providing the appropriate information. However, any paper that is signed, dated and provides the same information may be used. A directive may be made by anyone capable of making a health care decision and understanding the consequences of that decision.

Who do I talk to about these decisions?

It is strongly recommended you talk to your doctor before completing the directive. This will ensure your instructions are clear and easily understood by those who provide treatment. Your choices should then be clearly typed or printed.

What is a proxy?

A proxy is someone you choose and name in your directive to act for you in the event you are not able to make such judgments and speak on your own behalf. Because it is not possible to anticipate every set of circumstances, your proxy has the power to make health care decisions for you based on what you have told your proxy about your wishes and the information in your directive.

Who do I choose as my proxy?

The choices you make in a directive are very personal. The person(s) you choose to represent you should be close friends or relatives who are willing to accept this responsibility. You should discuss your wishes openly and in detail with them. It is wise to name more than one proxy in case one is not available when needed.

If you designate two proxies, you must decide how you want them to work, either independently or together as a team. If you decide the two proxies should act **jointly**, they will act together on your behalf. If you decide they should work **consecutively**, the second proxy will be contacted if the first is not available or is unwilling to make the required decision at the required time.

It is important to make sure that your proxy (or proxies) understand(s) what is expected and is willing to speak and act for you.

Can I change my mind about my directive?

A Health Care Directive should be a record of your current wishes. If at any time you wish to change the content or the proxies you have listed, all copies of your old directive should be destroyed and a new directive written.

What is the effect of a Health Care Directive?

The wishes you express in your directive are binding on your friends, relatives and health care professionals (unless they are not consistent with accepted health care practices) and will be honoured by the courts. However, health care professionals treating you are not obliged to search for or ask about a signed directive. It is important to be sure that family, friends, your doctor and your proxy know you have a directive and know where it can be found.

EMERGENCY INFORMATION

GENERAL INFORMATION ON EMERGENCY PREPAREDNESS FOR SENIORS

- Determine what emergencies could occur in your area.
 - ▶ Eg. Severe weather, flooding or tornadoes
- Meet with family or close friends to discuss the dangers of fire, severe weather, flood and other emergencies.
- ▶ Discuss how to respond to each emergency that could occur.
- Discuss what to do about power outages and personal injuries.
- Draw a floor plan of your home or residence and mark two escape routes from each room.
- Learn how to turn off the water, gas and electricity at main switches.
- Know how to use home fire extinguishers.
- Post emergency telephone numbers.
- Turn on a battery-powered radio for emergency information.
- Pick one out-of-area and one local friend or relative for family members to call if you are separated by an emergency.
- Pick two meeting places:
 - ▶ a place near your home in case of fire
 - ▶ a place outside your neighbourhood in case you cannot return home after the emergency.
- Keep family records in a water and fireproof container.

EMERGENCY CHECKLIST

Prepare an Emergency Supplies Kit for Your Home

- Keep a good supply of water on hand: one gallon per person per day. Store water in a sealed, unbreakable container. Replace stored water every six months.
- Have a supply of non-perishable packaged or canned food and a non-electric can opener on hand.
- Have a change of clothes, rain gear and sturdy shoes nearby.
- Be sure blankets or sleeping bags are available.
- Have a first aid kit and prescription medicines in your kit.
- Keep an extra pair of eyeglasses on hand.
- Have a battery-powered radio, flashlight and extra batteries for emergencies.
- Have credit cards, cash and traveler's cheques available.
- Keep an extra set of car keys close at hand.
- Have ready a list of family physicians, a list of important family information, the style and serial number of medical devices, such as pacemakers, stored in your emergency kit.
- See to the needs of elderly or disabled family members by keeping on hand special items for their use.
