

## Heating Appliances

Efficient furnaces, boilers and hot-water tanks are important to our comfort in the Northwest Territories. Is your heating source as efficient as it can be? Consider installing an emission neutral wood stove or pellet stove or replacing your furnace with a highly efficient model. Add an efficient water heater and you'll not only be cozy and warm all winter long, you'll also pocket the rebate rewards. Plus, you'll be saving energy and money for many years to come.

Woodstove	\$300 (EPA 40 CFR Part 60 or CSA - B415.1-M92 approved)
Wood pellet stoves and boilers	\$500 (ULC certified)
Heat recovery ventilator	\$300 (certified by the Home Ventilating Institute)
Oil furnaces and boilers	\$600 — oil boiler 85% AFUE* \$500 — oil furnace 85% AFUE* (and a DC variable speed motor) \$300 — oil furnace 83% AFUE*
Gas furnaces and boilers	\$600 — gas boiler 85% AFUE* \$500 — gas furnace 92% AFUE* (and a DC variable speed motor) \$300 — gas furnace 90% AFUE*
Hot water heating	\$500 — solar domestic hot water system \$200 — instantaneous hot water heater \$300 — condensing hot water heater \$300 — oil or gas hot water heater (non-hydro communities only)

\* AFUE — Annual Fuel Utilization Efficiency is a measure of the efficiency of heating appliances over a season or year.

## The Fine Print...

- This program is available to all NWT residents.
- Program will be in the form of a mail-in rebate for energy efficient appliances, heating appliances, vehicles, snowmobiles and outboard motors.
- This program is available for items purchased, or home retrofits completed, on or after April 1, 2007.
- Only products specified within this guideline are eligible for rebates. Please check with Arctic Energy Alliance for exact listing of products that qualify.
- Only products purchased through NWT dealers are eligible for rebates. A list of participating dealers is available on the Arctic Energy Alliance web site [www.aea.nt.ca](http://www.aea.nt.ca).
- Rebate forms are available at participating NWT retailers, Arctic Energy Alliance web site [www.aea.nt.ca](http://www.aea.nt.ca) or Environment and Natural Resources web site [www.enr.gov.nt.ca](http://www.enr.gov.nt.ca).
- Residents can apply for more than one rebate, to a maximum of two items per category per household, per year.
- EEIP provides matching grants that NWT residents receive through Natural Resources Canada's ecoENERGY retrofit program on qualifying retrofits of insulation, air sealing, doors, windows, skylights and water conservation.
- Businesses and non-profit organizations are eligible for incentives to a maximum of 10 products per incentive category, per year. Businesses and non-profit organizations are only eligible for rebates on replacement items.
- The Arctic Energy Alliance cannot be responsible for lost, late, incomplete or unreadable applications.
- Rebates are available as long as funds allocated by the Legislative Assembly of the Northwest Territories remain available.

### Evaluation:

- Final approval will be made by the Executive Director of AEA.
- Rebate forms must be complete and accurate to ensure prompt delivery of incentive.

The Energy Efficiency Incentive Program (EEIP) was designed to help homeowners and consumers purchase new, more energy efficient models of products that they use every day. Buying energy efficient products will help you save energy costs while reducing greenhouse gas emissions.

Here's what you'll get back when you purchase a qualifying model in these categories:

## How the EEIP Works

1. Purchase an eligible product from a participating NWT dealer. Participating retailers have the list of eligible products (and the application form) or check online at [www.aea.nt.ca](http://www.aea.nt.ca).
2. Complete the application form and attach a copy of the sales receipt. Make sure the sales receipt (proof of purchase) clearly indicates payment in full, the amount paid, the date of purchase, and the make and model of the product.
3. Mail, fax or deliver the application form and a copy of the sales receipt to the Arctic Energy Alliance.
  - The rebate application and sales receipt must be dated April 1, 2007, or later.
  - Please allow six weeks for delivery of your rebate cheque.

## Home Appliances

Your fridge and washing machine are two of the biggest energy users in your home. If you want to lower your electricity bill you can get a \$200 rebate if you live in a community powered by diesel or natural gas or \$100 if you live in a community served by hydropower. All you need to do is to purchase a new ENERGY STAR® fridge or front-loading washing machine. These two items use three to four times less energy than an inefficient model. Think of the savings!

## Snowmobiles and Outboard Motors

Boats and snowmobiles are a big part of life in the Northwest Territories. If you've been hearing about the new generation of four-stroke and semi-direct injection motors, now is the time to take action. Your local dealer can let you know which models qualify — with the help of a rebate from the EEIP, the choice is clear!

Snowmobiles	\$500 (Touring and Utility class 4-stroke + semi-direct injection snowmobiles)
Outboard motors	\$250 — less than 30hp \$500 — 30hp or greater
