- Purchase** a qualifying snowmobile or outboard motor on April 1, 2007, or after.
 - The rebate is for energy efficient snowmobiles or outboard motors purchased by NWT residents.
 - Participating retailers have the list of eligible models (and the application form) or check online at www.aea.nt.ca.
- Complete** the Application Form and attach a copy of the sales receipt.
 - Ensure the sales receipt (proof of purchase) clearly indicates payment in full, the amount paid, the date of purchase, and the make and model of the vehicle.
- Mail, fax or deliver** the Application Form, a copy of the sales receipt and proof of residency to the Arctic Energy Alliance, #101, 5102-51st Street, Yellowknife, NT X1A 1S7. Fax (867) 873-0303.
 - The rebate application and sales receipt should be received by the Arctic Energy Alliance within three months of the date of purchase.
 - The Arctic Energy Alliance cannot be responsible for lost, late, incomplete or illegible submissions.
 - Please allow six weeks for delivery of your rebate cheque.
