1.	 Purchase a qualifying vehicle on April 1, 2007, or after. The rebate is for energy efficient vehicles purchased by NWT residents to be registered in the NWT. Participating retailers have the list of eligible vehicles (and the application form) or check online at www.ecoaction.gc.ca/ecotransport/ecoauto-eng.cfm. 						
2.	Complete the Application Form and attach a copy of the sales receipt.						

- Ensure the sales receipt (proof of purchase) clearly indicates payment in full, the amount paid, the date of purchase, and the make and model of the vehicle.
