Appendix "A" - Sign Types

Formatted Signs

Formatted signs are standardized type signs that are approved for major highways. These signs have a standard format whereby the information included on the signs will be found in approximately the same location on all signs. The specifications include such things as a minimum letter size so as to ensure legibility at



the posted speed limit, appropriate fonts, colour selection, tab and/or logo sizes, and material options for fabrication. Business New Brunswick (BNB) has developed specs for formatted signs and is responsible for determining the types of "specific interest" facilities eligible for signing outside the right-of-way.

The administration for signing outside a city or town along the major highways is the responsibility of the Department of Transportation (DOT). DOT regulates such factors as the size, location, spacing, and distance of highway advertisements. The administration of signing outside the right-of-way within a city or town along the major highways falls under municipal bylaws.

Facility operators need to obtain a permit for formatted signs outside the right-of-way along the major highways and there is a cost associated with the permit. Facility operators are responsible to negotiate with the private sector for the manufacture and installation of these formatted signs on private land.

DOT recognizes that:

- there are sections of two lane highway where additional lands have been purchased for future widening of the two-lane highway to a four-lane highway, and
- 2) sections along some highways where excess land may have been acquired beyond the normal right-of-way width for the highway.

In these instances DOT will permit private advertisements within those portions of right-of-way that are wider. There is a fee associated with placing a sign within these sections of right-of-way and the fees are comparable for placing a sign on private land outside the right-of-way.

"Welcome To" Municipality Signs

These signs are permitted within the highway right-of-way and are subject to standards for signing within the right-of-way. As well the location of these signs has been standardized in a prominent location on the backslope. Should municipalities wish to have more flexibility in the design of their "welcome to" sign than that which is allowed on the right-of-way, then, the sign will have to be installed just outside the



highway right-of-way. In situations where access at an interchange could be for more than one municipality (such as Campbellton/Atholville, Sussex/Sussex Corner, or Beresford/Nigadoo), consideration will be given to allowing more than one municipality on a "welcome to" sign. Another alternative is, in cases where an area is bypassed, a "welcome to a region" sign could be installed in place of a "welcome to" municipality sign (such as "Welcome to" the Fredericton Region).

Major Attraction Signs

BNB uses criteria to classify and identify the province's Major Attractions. All attractions, whether private or public, may apply to BNB to be considered for Major Attraction status. It is understandable that New Brunswick wants their Major Attractions identified on the arterial



highway system. Therefore, Major Attractions will be given the opportunity to sign on the nearest arterial highway.

Secondary Attraction Signs

As stated above BNB apply criteria to classify attractions. Again, any attraction, whether private or public, may apply to BNB to be



considered for Secondary Attraction status. Secondary Attractions are considered significant enough to intercept the visitor and perhaps lure them off the major highway system.

Regular Attraction/Service Signs

Attractions or services that do not fall under the Major or Secondary classification are considered as Regular Attractions or Services. Regular Attractions/Services are eligible for Tourist-Oriented Directional (TOD) signs on highways other than level I, II or connector I highways. Included in the Regular Attraction/Service category are the Rural Tourism Operators. In the past rural tourism operators were permitted TOD signs on the 2-lane level I, II and connector I highways if the facility was not located within the limits of a city, town or village and if the facility could not be seen from the highway. Under the amended regulation,



TOD Regular Attraction signs and TOD rural tourism operator signs will be phased out on the level I, level II and connector I highways in favour of formatted signs outside the highway right-of-way.

Visitor Information Centre Signs

As with Major Attractions and Secondary Attractions, Visitor Information Centres qualify to have TOD signs within the right-of-way along all classes of highways in the province. Over the past few years the vast majority of jurisdictions have changed from Tourist Information to Visitor Information and New Brunswick, in keeping with the times, has changed their publications, and will change the signing to "Visitor Information".



Guide Signs

Signs are used, in part, as a form of traffic management that provides information to the road user. Guide signs are usually green in



colour and contain information on the location of municipalities or communities found along a route or off a specific route. They are installed in accordance to national standards and policies and form part of the

highway system. Several sections of the Highway Advertisements Regulation refer to a specific distance from a DOT guide sign. Guide

signs should not be confused with warning or regulatory signs. Warning signs warn of road characteristics, hazards and temporary



conditions such as curves, bumps, road narrows, etc. Regulatory signs advise of traffic regulations such as speed limits, stop signs, no left turn, etc.

Other Highways

Private advertisements are allowed one metre outside the right-of-way on the other highways such as local named roads and routes such as Routes 3, 4, 10, 16, 114, 260, 950, etc. provided the facility being advertised meets the definition of "specific interest." Formatted signs are not a requirement on these other highways although DOT still regulates such things as size, location,



spacing, and distance, and you will require a permit from DOT in order to install one of these signs along an arterial or collector highway.

Other Considerations

Colour

Tourist related signing throughout most of Canada and the US is changing to blue. New Brunswick currently uses blue for private sector



signing and burgundy for public sector signing. To be more consistent with other jurisdictions and to reduce production costs, all public sector tourist related signing programs are changing to blue.

Format

The word destination is a term used by transportation departments across North America and refers to the green destination/guide signs DOT installs to direct motorists to municipalities and communities. Other provinces and states that have programs similar to the former Destination Information Signage Program (DISP) refer to their programs as TODS or Tourist-Oriented Directional Signs. Therefore, the name of the Destination Information Signage Program (DISP) will change to Tourist-Oriented Directional Signing Program (TODS) and the word "Destinations" will be removed from the white stripe on tourist-oriented directional signs.

Things you will have to know to fill out an application form for private advertisements outside the highway right-of-way

U	The route number or road name where you want to install your advertisement
	The distance between your advertisement and any advertisement, up to 500 m before and after
	The distance between your advertisement and a DOT guide sign, up to $500\ \mathrm{m}$ before and after
	The distance between (4 km before and 1 km after) your advertisement and any intersections or interchanges
	The distance your advertisement will be from the centreline of the highway
	The distance from your sign location to your business
	Dimensions of your advertisement
	What your sign is advertising
	The name, address and phone number of your business
	The land owner's name, address and phone number where your advertisement will be located
	The parcel identification number of the land where the sign will be located
	The sign manufacturer's name, address and phone number
	The template design number & designated colour numbers (if applicable) of the template you will be using for your sign – SEE Appendix "D" $^{\circ}$
	Whether the location where you want to place your advertisement is within a city or town
	The EXIT number you will be including on your sign (if applicable) – SEE Appendix "G"

Please read your package and regulation carefully

Help in filling out the application form is available at any DOT district / administrative office

- 1. Complete the application form for an advertisement permit complete with template design number and designated colour numbers.
- 2. Submit to the DOT District Office for approval along with application fees.
- 3. Please allow 3 weeks for approval/refusal from DOT. Permit will be sent to you by mail unless requested otherwise.
- 4. Building permit: DOT will enclose a building permit application and the name and address of the Development Officer with your approved Highway Advertisement Permit.
- 5. You must obtain a building permit before you can install your advertisement.
- 6. Please ensure you follow the regulation carefully when filling out your application form and when installing your advertisement. Any deviations from the information you provide on the application form may result in the removal of your advertisement.

Appendix " C " - What Makes An Effective Sign

Signage Usability and Effectiveness


Signage must address human behaviour factors. On Level I and II highways, where speeds exceed 90 kilometres per hour, effective signage considers:

- drivers have only 6 to 10 seconds to locate and read a sign
- drivers require about 1 second to read each word or symbol
- consistent signage is spotted more readily by drivers
- drivers must continue to watch the road
- driver manoeuvrability time
- legibility distance
- the smallest critical detail must be legible
- sign must contrast with the background
- sign must be located easily
- sign must be read quickly
- sign must contain only information that is needed
- sign letters must be of sufficient height and spacing
- sign letters must be of a specific, clear font for highway visibility
- sign symbols must be understood by the driver





Formatted Sign Specifications

Sign Face Size

- the height should be no more than 50-75% of the width of the sign
- maximum size 65 sq metres
- face to be constructed of crezon* or better
- graphics and lettering must be applied in vinyl (3M Vinyl or comparable)
- graphics are to be computer-generated
- signs are not to be hand-painted
- vinyl is not to be hand-cut

Lettering

- letters to be mixed case
- company name = preferred letter size for upper case letters = 20"
- company name = preferred letter size for lower case letters = 15"
- company name = minimum size for upper case letters = 16"
- company name = minimum size for lower case letters = 12"
- additional information = minimum letter size for upper case letters = 13"
- ~ additional information = minimum letter size for lower case letters = 10"
- exit bar information = minimum letter size for upper case letter = 13" (note: if using the word EXIT, it is recommended that it be written in all caps)
- ~ exit bar information = minimum letter size for lower case letter = 10"
- ~ font choice of: 95 Helvetica Black, Clearview, Series E(M), or Interstate

Spacing

- letter spacing shall be 25% 30% of the letter height
- line spacing = height of lower case letter

Logos/Images

- no more than one logo or image
- ~ height to be a minimum of 36" (90cm)
- there are no colour restrictions for logos or images

^{*} Crezon is a treated plywood for exterior usage.

Colours

- limited to 3-5 different colours
- minimum of 50% contrast between sign letter and background colour (ex. red or black on white)
- specific colours are given for use in signage templates (see below)

Exit Bar

- exit bar height = 20"
- exit bar colour = Royal Blue 3M 3630-87
- only directional information may be included on the exit bar

Tabs

- tabs size to be 30" x 30" (75 cm x 75 cm)
- number of tabs to be determined by sign size, to a maximum of 4

Posts

 shall be sufficient in number and size so as not to require bracing (aluminum recommended)

Sign structure

- must be self-supporting with no knee braces or guide wires
- bottom of sign face must be a minimum of 2.4 m (8 feet) over ground level
- Crezon panels should be mounted on a galvanized metal structure (angle or tubing)

Language

Language of choice is up to the applicant and may be bilingual
