NOTICE OF APPLICATION AND PUBLIC HEARING

NEWFOUNDLAND AND LABRADOR HYDRO'S 2005 CAPITAL BUDGET APPLICATION

TAKE NOTICE that on August 10, 2004 the Newfoundland and Labrador Board of Commissioners of Public Utilities (the "Board") received an application from Newfoundland & Labrador Hydro ("Hydro"), pursuant to sections 41and 78 of the Public Utilities Act ("the Act") requesting an order of the Board:

- i) Approving Hydro's 2005 Capital Budget in the amount of \$ 42,431,000;
- ii) Approving Hydro's 2005 Capital Purchases and Construction Projects in excess of \$50,000;
- iii) Approving Hydro's 2005 Leases in excess of \$ 5,000;
- iv) Approving Hydro's proposed estimated Contributions in aid of Construction of approximately \$240,000; and
- v) Fixing and determining Hydro's average Rate Base for 2003 in the amount of \$1,422,412,000.

AND FURTHER TAKE NOTICE that any or all customers of Hydro may be affected by the proposed application.

THE PUBLIC HEARING:

The public hearing of Hydro's application will begin at **10:00 A.M. on October 6, 2004**, in the Board's Hearing Room, Prince Charles Building, 120 Torbay Road, St. John's. The hearing will proceed in accordance with the procedures of the Board, which are established in accordance with the Act and *Newfoundland Regulation 39/96* ("the Regulations") with respect to filing of evidence, requests for information, and other matters relating to the hearing.

HOW TO PARTICIPATE IN THE HEARING:

Any interested person or organization can participate in the hearing in one of three ways, as follows:

- Intervenor Submission Any person wishing to be made a party to the hearing must apply by way of an Intervenor's Submission to the Board as set out in section 9 of the Regulations. This submission should concisely state the interest such person has in the Application, the facts and reasons which will be entered as evidence (together with any supporting documentation) and the disposition of the proceedings which the Intervenor advocates. All Intervenor Submissions must be received by the Board before 12:00 Noon, Monday, September 13, 2004.
- 2) Letters of Comment Any interested person who does not wish to intervene or make an Oral Presentation may file a Letter of Comment for the consideration of the Board in this proceeding. All Letters of Comment must clearly state the person's interest in the proceeding, together with any comments and other relevant documentation that may be useful in explaining or supporting those views, along with their address and telephone number. The Board will accept all Letters of Comment received before the closing day of the hearing.
- 3) Oral Presentation Any interested person who does not wish to intervene to become a party in the proceeding but who wishes to make an Oral Presentation to the Board must request and obtain permission of the Board to make such presentation during the hearing. Persons or organizations interested in making such oral presentations, must write a letter of comment which clearly states the person's interest in the proceeding, together with any comments and other relevant documentation that may be useful in explaining or supporting those views, along with their address and telephone number. Oral Presentation requests must be received by the Board before 12:00 Noon, Thursday September 30, 2004.
