NOTICE OF HEARING AND INVITATION FOR PUBLIC PARTICIPATION

NEWFOUNDLAND POWER INC. 2003 GENERAL RATE APPLICATION

The public hearing of Newfoundland Power Inc.'s 2003 General Rate Application (the "Application") will begin at 9:00 a.m. on Monday, March 3, 2003 in the Board's hearing room, Prince Charles Building, 120 Torbay Road, St. John's. The Notice of Application and Pre-hearing Conference, which included the request for intervenor submissions, was published in newspapers across the province beginning October 19, 2002. At the pre-hearing conference on October 30, 2002 the Board set the schedule for the hearing of the Application and established the list of intervenors for the proceeding.

On February 10, 2003 Newfoundland Power re-filed its application, modifying the proposed average rate increase from 1.39% to 0.96%, with specific impacts on customers varying depending on electricity consumption.

During the hearing the Board will hear direct testimony and evidence from the Applicant and registered intervenors, followed by public presentations. Registered intervenors in this hearing are the Consumer Advocate, Mr. Dennis Browne, and Newfoundland & Labrador Hydro.

Invitation for Public Participation

Interested persons or organizations other than registered intervenors can participate in the proceeding in one of the following two ways:

1) Oral Presentation - Any person or organization who does not wish to formally intervene in the Application and thereby become a party in the proceeding, but who wishes to make a presentation to the Board, may request the opportunity to make an Oral Presentation during the time scheduled for public participation. Persons or organizations interested in making an Oral Presentation must write to the Board outlining their interest in the proceeding, along with their address and telephone number. The Board will consider travelling to other regions served by Newfoundland Power where public interest is demonstrated and interested persons or organizations have confirmed participation.

The deadline for submitting requests to make oral presentations to the Board is 3:00 p.m. Friday, February 28, 2003. The Board will finalize the dates and locations for public participation, based on the submissions and interest it receives, and issue a follow up notice of the schedule.

2) Letter of Comment - Any interested person or organization who does not wish to intervene or make an Oral Presentation may file a Letter of Comment for the consideration of the Board. All Letters of Comment must clearly state the person's interest in the proceeding, and the person's views regarding the proceeding, together with any relevant information that may be useful in explaining or supporting those views.

The Board will accept all Letters of Comment received before the closing day of the hearing.
