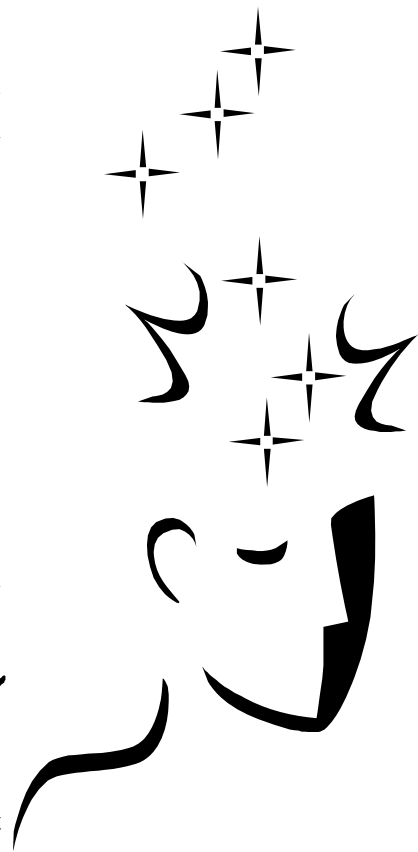

Introduction

The annual report for 2006-2007 academic year marks significant achievement for the faculty, staff and students in the Division of Community Health and Humanities. The integration of Community Health and Humanities in 2005 created opportunities for collaboration and innovation. This year we continued to experience the rewards and challenges of this new alliance.

Academic achievements include: several awards to faculty and students, the graduation of five MSc students in Community Health, and four students graduating from the Applied Health Service Research program, the creation of new courses for the graduate program and the revision of the Community Health curriculum for the medical program. The proposed MPH program underwent external review and is currently in the process of review by Academic Council. We are optimistic that it will receive approval in the next academic year. The Division also became a partner in a Public Health Agency funded collaborative with 4 other universities to improve public health for rural, remote and aboriginal communities. Staff continue to participate in academic courses to improve their knowledge and skills which brings added value to the support service they provide to the Division. The Division also hosted a number of informative seminars and guest speakers for the Faculty of Medicine.

It was another successful year in research with faculty involved in 22 new research projects and 27 ongoing projects. Faculty are partners in new research valued at several million dollars. The Health Research Unit continues its support of research in the community with 10 ongoing projects in 2006/07.

Faculty and staff provide service to the Faculty of Medicine, the university and the community through their participation in a number of advisory committees and projects including many at national and international levels.

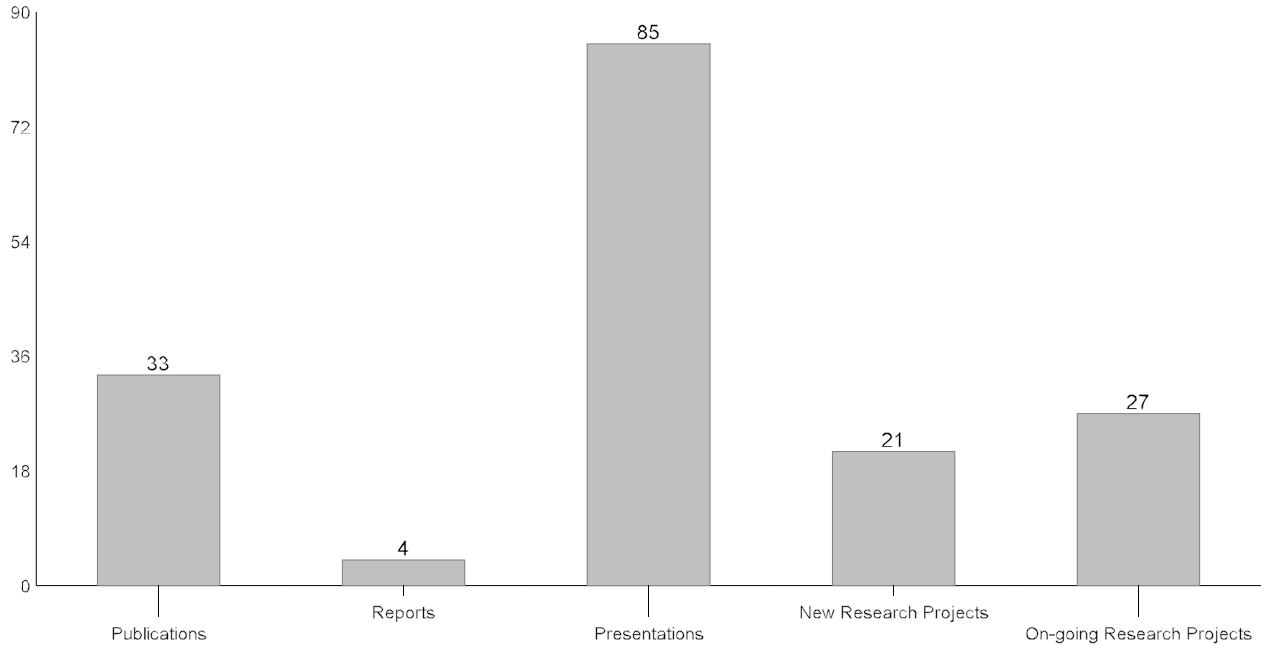
Faculty vacancies continue to challenge the division although with the help of part-time, adjunct and cross-appointed faculty we have been successful in full-filing our commitments. Two faculty positions remained vacant this year and unfortunately we lost the services of Dr. Andria Jones late in the academic year. We are in the process of recruiting for these positions. We were successful in the search for two Canada Research Chairs, Dr. Wendy Young will assume the Chair in Health Aging (joint with the School of Nursing) and Dr. Martha Traverso in Health Promotion. We hope they will join us in the next academic year. Dr. Jim Connor resigned from the position of Associate Dean for the Division however we are fortunate in that he continues as the John Clinch Professor of Medical Humanities & History of Medicine.

In the next year we are looking forward to the opportunities new programs, new curriculum and new faculty will bring.

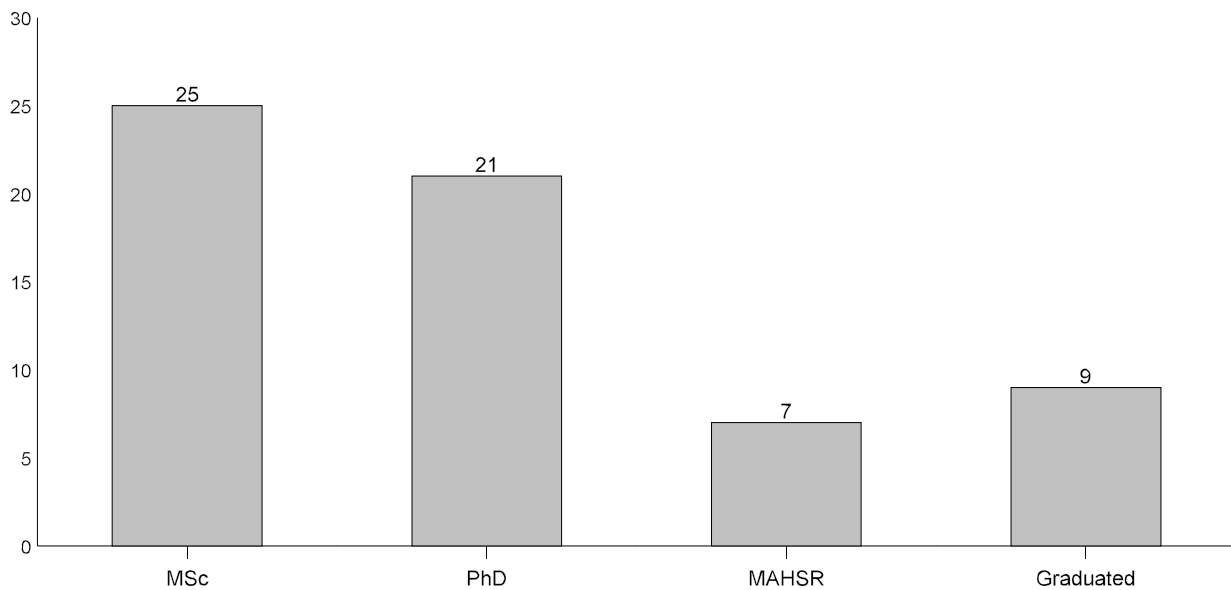

MSC APPLIED HEALTH SERVICES RESEARCH

This program, which is a collaborative venture between Dalhousie University, Memorial University, the University of New Brunswick, and the University of Prince Edward Island, has just completed its third year. Funded by the Canadian Health Services Research Foundation, this two-year program offers courses through synchronous and asynchronous web-based formats that are designed to provide a similar learning environment with standardized course content. The program is intended for students with little or no background in the healthcare field and little or no experience in conducting research. Through scholarly research techniques, a residency placement, and eight courses in healthcare research, students are able to demonstrate a grounded understanding of applied health services.

Canadian Heart Health Database Centre

AIMS:

The primary aim of this Centre (CHHDBC) was to provide technical support to the Canadian Heart Health Initiative (CHHI) in the form of developing databases, their upkeep and analysis, to further Heart Health in Canada. A Web page to facilitate sharing of CHHI information is managed by the CHHDBC. The Centre now provides this support to other databases and web pages as listed below.

DESCRIPTION:

With support from the CHHI and Health Canada, the ten provincial risk factor surveys were combined into a national database containing data from over 23,000 individuals; this dataset is available on CD ROM from the Database Centre. Further databases have been developed by the CHHDBC including the CHHI Process Evaluation Database, and the CHHI Health Promotion and Chronic Disease Prevention Resources Database. An international G8 Promoting Heart Health Database containing information on noteworthy initiatives was developed and is also searchable on the web (www.med.mun.ca/g8hearthealth). Canadian and international projects from the G8 database have been incorporated into the Repository of International NCD Prevention Interventions database and webpage (www.med.mun.ca/rinpi).

IMPACT/FUTURE PLANS:

The current web page and databases will continue to be supported by the Division of Community Health and Humanities.

CURRENT PROJECTS:

- (1) ***Repository of International NCD Prevention Database and Web Page***
The database currently contains over 425 projects.
- (2) ***Data Custodian for the 1994/5 and 2001 Adult Health Surveys***
Following a signed agreement between the University and the Newfoundland and Labrador Statistics Agency (NLSA), the data from the NLSA's 2001 Adult Health Survey is now available to researchers at MUN (subject to HIC approval). This agreement also included the provision that earlier datasets, collected by the late Dr. Jorge Segovia, will be archived at the NLSA.
- (3) ***Data Entry and Database Maintenance for the Early Psychosis Program. Health Care Corporation of St. John's***
Data entry has continued throughout this year.
