

- 16. Example of a Chargeback description a manual imprint of the credit card was not taken or the credit card was not taken or the credit card number was manually keyed into the terminal
- 17. Example of a Chargeback description credit card was not present at the time of the purchase or the credit card used in the transaction was fraudulent
- 18. Miscellaneous fees \$99 is the installation fee; \$25 is the application fee; (\$3.39 is a pro-rated monthly fee for the installation of an additional terminal – varies per diem in relation to the number of days that are in the remainder of the month)
- 19. HST for the pro-rated fee paid for that month
