	<u>R14(4)(e)</u> and paragraph 8 of Schedule II do not exempt the civilian personnel from the passport and visa requirements but they are not required to pay a fee with their application - <i>Immigration Act Fees Regulations</i> - item 3(2)(b).
	They are exempted from the employment authorization requirements - <u>R19(1)(b)</u> .
