

This publication lists these new prescribed rates as well as the rates which apply to the periods before July 1, 2003.

Goods and Services Tax / Harmonized Sales Tax (GST/HST) and the Air Travellers Security Charge (ATSC)

The annualized prescribed rates of interest with respect to the GST/HST and the ATSC are listed below.

To calculate interest, divide the annualized rate by 365 (366 during a leap year) and apply it daily.

In addition to interest, a penalty of 6 per cent per annum applies on all late remittances. Penalty and interest are compounded daily based on the total tax (or security charge), penalty and interest outstanding.
