## Good Afternoon,

To follow up on the telephone conversation of April 23, 2013 with a representative of your office, we would like to provide some additional information that will be of assistance to you when searching for Information Requests or Responses to Information Requests in the future.

The Joint Review Panel requested Ontario Power Generation (OPG) to submit a consolidated table of all of the Panel's Information Requests (IRs) and the Responses to those IRs to make it easier for participants to look at one document versus the overwhelming number of documents that are now contained on the registry. The Consolidated Table is regularly updated and is in a PDF format which is searchable. CELA will be able to search on a key word or phrase from one of its original proposed information request (PIR) submissions and be able to determine if the Panel incorporated it into any IR Packages submitted to OPG.
