#### Subjects Discussed:

1. **Hearing Logistics:** Secretariat has begun planning for the hearing by investigating potential venues in the project area; for planning purposes, Secretariat is assuming that the hearing will be held this fall (sometime in September and/or October)
2. **Potential Hearing Locations:** Secretariat is investigating venues in the area of Kincardine and Port Elgin; Port Elgin would provide acceptable access to SON members
3. **Procedures for Public Hearing:** Secretariat expects these will be available/released when the Panel announces the hearing
4. **SON Submissions:** proposed information requests received by the Panel; Panel can expect to receive additional information from the SON on rights and interests by June 14, 2013; SON intends to continue to participate and provide information through other submissions at later stages of this
5. **Follow-up Teleconference:** scheduled for May 23, 2013; to discuss possible steps to be taken to make the hearing open to the SON membership and responsive to their needs
