Saugeen Ojibway Nation

- Meetings
 - Meeting was held on January 22, 2013
- Issues Raised
 - SON requesting that DGR and APM be discussed together
 as per their cumulative effects application made to the JRP
 - No guarantee that the project won't impact them they are already feeling socio-economic impacts
 - SON wants to be part of the decision-making process the project is proposed in their traditional territory
 - Free, Prior and Informed Consent included in the United Nation Declaration on Rights for Indigenous Peoples
 - Crown/SON relationship is beyond s.35 Duty to Consult

Saugeen Ojibway Nation

- Proposed next steps (from Jan 22 meeting)
 - Bring concerns to the JRP
 - Subsequent meeting to continue discussions
 - Staff to bring concerns regarding APM to NWMO and NRCan
 - CNSC staff to consider technical sessions with the SON with respect to concerns brought forward

Métis Nation of Ontario

- Meetings
 - Two meetings held since last update
 - October 18, November 29 2012
 - Presentation given to CNSC staff on consultation protocol and shared information on culture and customs
- Issues Raised (via submissions/meetings)
 - Lack of Aboriginal representation on JRP
 - Relationship building very important
 - EA does not recognize socio-economic environment of Métis
 - MNO feel they were not consulted on selection VECs
 - Consideration of Métis rights
 - Identification of appropriate "Duty to Consult" requirements of the Minister of Environment
- Traditional Land Use Study for OPG and JRP expected to be submitted as well as more comments on EIS
 - CNSC staff to review Traditional Land Use Study based on the EIS findings to determine any impacts to Métis rights

Historic Saugeen Métis

- Meetings
 - Meeting held October 17, 2012
- Other
 - HSM shared with CNSC staff a presentation on the history of their people in the Saugeen area.
 - The HSM "Atlas" is expected to be ready in early 2013
 - No other concerns or issues brought forward at this time

United Chiefs and Councils of Manitoulin

Correspondence

 The UCCM extends an invitation to the JRP to come visit – reiterated in a letter to CNSC staff dated September 24, 2012

Issues

 UCCM is interested in speaking directly to the JRP and will be sending a letter directly to the Panel.

Wikwemikong Unceded Indian Reserve

- Meetings / Planning of Meetings
 - CNSC has extended an offer
 - No further meetings requested
- Issues
 - None raised at this point

Haudenosaunee Confederacy Chiefs

- Correspondence
 - CNSC staff continue to send all updates via letter mail and e-mail
- Issues
 - HDI sent a letter requesting CNSC pay their consultation fee, and indicating that the DGR project may have an impact within their treaty area
 - CNSC staff responded requesting the following information:
 - the First Nation(s) representing by HDI
 - written confirmation from the respective First Nation that HDI has been authorized with delegated authority to speak on behalf of that First Nation
 - a First Nation based contact, apart from the HDI, for each First Nation listed.
 - No response has been provided from the HDI or from the Haudenosaunee
 Confederacy Chiefs (cc'd on letter to HDI)
 - CNSC staff continues to send correspondence to the main contact address for the Haudenosaunee Confederacy Chiefs
