### **Deputy Minister of Justice Lesley McCullough- Chair**

Lesley McCullough is a graduate of F.H. Collins Secondary School in Whitehorse, Yukon and has a B.A. (Hons.) from the University of Alberta and an LL.B. from Queen's University.

Lesley has worked for the Government of Yukon for over 25 years. As Deputy Minister of Justice, she is responsible for courts, policing and public safety, legal services and a number of regulatory services. Immediately prior to becoming Deputy Minister, Lesley was the Assistant Deputy Minister for Court and Regulatory Services and in that position spearheaded the modernization of the land titles system in Yukon which included replacement of century old legislation, design of modern business processes, introduction of a supporting platform and the creation of new ways of addressing First Nation Settlement Land in a land titles system while maintaining aboriginal title. She has also held the position of Director of Intergovernmental Affairs in the Executive Council Office and worked in what is now the Yukon's Aboriginal Relations Office as Director of Mandate and Policy and as counsel to the Yukon in the negotiation of the Umbrella Final Agreement, and Yukon First Nation Final and Self-Government

Agreements. Lesley has extensive legal and policy experience in the area of real property law, governance and aboriginal rights.

### **Lisa Anderson**

Lisa joined the Yukon Police Council as a member in 2012. Lisa is a member of Tr'ondek Hwech'in First Nation and brings a variety of experience including positions in: Public Service Alliance of Canada Union; Yukon Territorial Government; and, Tr'ondek Hwech'in First Nation as the Implementation Officer & Registrar. Lisa also has vast council and committee experience serving as a member on: Tr'ondek Hwech'in Justice, Tr'ondek Hwech'in Land Claims, First Nation Justice Network, and National Aboriginal Inuit and Metis Circle as the North Female Representative.

### **Elodie Dulac**

Elodie joined the Yukon Police Council in 2015. Elodie comes to us from Kluane First Nation and has had a long career working in Haines Junction in such areas as advertising, administration and First Nations housing. Elodie has also owned several businesses and is the proud mother of 6. She has shown a knack for identifying opportunities and projects where she can inject clarity and cleanliness to achieve positive results in a quick and efficient manner.

### **Tracy MacPherson**

Originally from the Northwest Territories, Tracy belongs to the Fort Resolution Metis Local #53. Tracy is very familiar with the Yukon as she did her schooling from grade one to twelve in Whitehorse. She left the Yukon in 1989 to pursue her education at Aurora College in Fort Smith, NT. Tracy completed a social work diploma in 1991 and worked for the Government of the Northwest Territories until returning to school in Regina in 1993. She completed her Bachelors of Social Work degree in 1995 and her Masters in Calgary in 1997. Tracy returned to the NT in 1997 and lived in Fort Simpson, Inuvik and Fort Smith, working in areas including: corrections, community corrections, child protection and education. In 2013, she returned to the Yukon, living in Haines Junction and working for the Champagne and Aishihik First Nations as their Director of Community Wellness. Tracy moved back to Whitehorse in August 2015 and is currently employed with First Nations Health at the Whitehorse General Hospital
