The Canadian Patient Safety Institute and the Public Health Agency of Canada hosted a national infection prevention and control (IPAC) summit in November 2014. Over 40 participants came together with the goal of advancing IPAC practices and reducing healthcare-associated infections in Canada. At this meeting, measurement and surveillance, specifically improving consistency in surveillance practices across the country, surfaced as a key theme and an action plan was created. Under the leadership of Infection Prevention and Control Canada (IPAC Canada and the Association of Medical Microbiology and Infectious Diseases Canada (AMMI Canada) a committee was created to help establish and implement standard healthcare infection surveillance definitions for healthcare associated infections (HAI) in acute care and long term care (LTC).

Members of IPAC's Surveillance and Epidemiology (SAEIG) and Long Term Care (LTC) Interest Groups and the L'Association des infirmières en prévention des infections (AIPI) formed a working group to revise the existing Stone et al. (2012) LTC infection surveillance definitions based on the Canadian healthcare system and an increase in evidence-based literature about some types of infection in the elderly in LTC settings. The Centers for Disease Control (CDC) Healthcare Infection Control Practices Advisory Committee (HICPAC) guideline development methodology was used to revise the definitions.

colonized even after symptoms resolve. In the setting of an outbreak of GI infection, individuals could have positive test results for presence of *C. difficile* toxin because of ongoing colonization and also be co-infected with another pathogen. It is important that other surveillance criteria be used to differentiate infections in this situation.
