Eligibility Requirements

You are accountable for the infection prevention and control activities/program in your setting and this is reflected in your current job description.

AND

You have a post-secondary degree (e.g. associates'* or baccalaureate degree).

AND

You have had sufficient experience (recommended: two years) in infection prevention and control which includes all three (3) of the following:

- Identification of infectious disease processes
- Surveillance and epidemiologic investigation
- Preventing and controlling the transmission of infectious agents

And at least two (2) of the remaining five (5) components:

- Employee/occupational health
- Management and communication
- Education and research
- Environment of care
- Cleaning, sterilization, disinfection, and asepsis

If you meet all eligibility requirements, you are eligible to take the computer-based test (CBT) to become Certified in Infection Control (CIC°).

Taking the CBT

Once you receive access to the exam from CBIC's testing agency, Prometric, you have 90 days to schedule and take the examination. Prometric has thousands of Test Centers worldwide. To find the Prometric Test Center nearest you, go to www.prometric.com/cbic.

To ensure that all candidates are tested under equally favorable conditions, Prometric implements a number of testing regulations. Please visit www.cbic.org/certification/exam for a list of regulations and documentation needed to take the examination.

Recertification

CIC°s must recertify every five years. To recertify you will need to take the Self-Achievement Recertification Examination (SARE). The SARE is an online test that can be taken on any computer. The SARE must be submitted by December 31st of the fifth year of certification to avoid a lapse in certification. Unlike the CBT, the SARE does not need to be taken all at once. You can answer one question a day, save and come back to it if you would like, as long as it is submitted by the December 31st deadline.

CIC[®] Designation

Upon successfully passing the CBT, you will be able to use the CIC* designation immediately. You will receive your certificate in the mail within 4-6 weeks.
