- 1. THIS TRIBUNAL ORDERS that an Easement and Right-of-Way being comprised of 6.42 acres, designated as Part 2 on Plan 48R-3585, across Mining Location K.74 in the District of Rainy River, as described in Instrument Number 3103, owned by George Ansley Armstrong, be vested in Nipigon Gold Resources, Ltd.
- **2. THIS TRIBUNAL FURTHER ORDERS** that an Easement and Right-of-Way comprised of 5.16 acres, designated as Part 1 on Plan 48R-3585, across Mining Location K.75 in the District of Rainy River, as described in Instrument Number 2523, owned by Kirsti Alice Armstrong, be vested in Nipigon Gold Resources, Ltd.

IT IS FURTHER DIRECTED that upon payment of the required fees, this Order be filed with the Land Registrar of the Registry Division of Rainy River.
