ORDER OF THE TRIBUNAL DELIVERED BY D. STEPHEN JOVANOVIC

REASONS

Background

[1] Northern Gold Mining Inc. ("Northern Gold" or "Applicant") (ENDM Client No. 403059), has applied to the Tribunal for an order, under s. 68 of the *Mining Act* ("Act"), to vest the interests of co-owner GeoProMining Gold Canada Ltd. ("GeoProMining") (ENDM Client No. 194505) in Northern Gold.

- [2] Northern Gold is the recorded holder of an 87.5% interest in the subject Mining Claims listed in Schedule A attached hereto, situate in the Townships of Garrison and Thackeray, in the Larder Lake Mining Division. GeoProMining is the recorded holder of a 12.5% interest in the same Mining Claims referred to above.
- [3] Preliminary materials in this matter were filed in February 2016. Supporting materials for the application were received from Tania Poehlman, Land Manager for Northern Gold, to the Tribunal on March 20, 2019.

RELEVANT LEGISLATION

[4] Section 68 of the Act states that:

68 Where two or more persons are the holders of an unpatented mining claim, they shall contribute proportionately to their respective interests, or as they otherwise agree between themselves, to the work required to be done thereon or to a survey, patent or the first year's rental of a lease, and, in case of default by any holder, the Tribunal, upon the application of any other holder and upon notice to and after hearing all persons interested or such of them as appear, may make an order vesting the interest of the defaulter in the other co-owners or in any of them upon such terms and conditions and in such proportions as it considers just.

ANALYSIS

- [5] Northern Gold claims that GeoProMining is in default of its obligation to perform its share of the assessment work. In support of the application, the Applicant set out in an affidavit from Ms. Poehlman sworn to on March 20, 2019, that it owns 87.5% of the Mining Claims; that GeoProMining owns 12.5% of the Mining Claims and that the affidavit was made for the purpose of applying under s. 68 of the Act for an order vesting GeoProMining's interest in Northern Gold. The affidavit further set out that GeoProMining "has never performed or filed any prescribed assessment work on the mining claims."
- [6] The Tribunal obtained a Yukon Corporation Report ("Report") from Yukon Community Services; (part of the Government of Yukon's Department of Community Services) dated February 7, 2017, which indicated that GeoProMining's registered office delivery address was 200 204 Lambert Street, Whitehorse, Yukon. The Report also

confirmed that GeoProMining was incorporated on January 1, 2005 and was dissolved by its directors on June 13, 2016, pursuant to s. 212 and 213 of the Yukon *Business Corporations Act*. No subsequent name changes, amalgamations, related entities or continuances exist.

- [7] The Tribunal notes that the Applicant, as stated in the affidavit, undertook extensive efforts to locate any signing officers or any staff representing GeoProMining. However, these efforts were unsuccessful.
- [8] Abstracts for the Legacy Mining Claims (now the cell and boundary mining claims as outlined in Schedule A which form the subject matter of this application) from January 6, 2017, confirmed numerous transactions outlining the performance and filing of prescribed assessment work by the Applicant from August 29, 2013 onwards. The Applicant also confirmed in its supporting affidavit that GeoProMining had not performed any work on the Mining Claims, nor had it paid for any of its proportionate share of assessment work as a co-holder.
- [9] This matter is a case in which the co-owner of the Mining Claims has been in default of its obligation to pay and/or to perform its proportionate share of assessment work, within the meaning of s. 68 of the Act. The Tribunal finds that GeoProMining has not met its obligations and will grant the application to vest the interest of GeoProMining in the Applicant. This will result in Northern Gold having a 100% interest in the ownership of the Mining Claims.
- [10] The Tribunal notes that the Applicant is not seeking an extension of time in which to perform and file prescribed assessment work on the Mining Claims, that it has kept the Mining Claims in good standing and that the due dates for the Mining Claims are in 2021 and 2022.

ORDER

[11] The Tribunal directs that the interest of GeoProMining in the Mining Claims, be

and is hereby vested in the Applicant, Northern Gold, pursuant to s. 68 of the Mining

Act.

[12] The Tribunal further directs that no costs shall be payable by any party to this

application.

[13] The Tribunal further directs that, pursuant to s. 129(4) of the *Mining Act*, a copy

of this Order shall be forwarded to the Provincial Mining Recorder who is hereby

directed to amend the records in the Provincial Recording Office as necessary.
