PRINCE EDWARD ISLAND LANDS PROTECTION ACT PROPERTY NO. 167767, LOT 55, KINGS COUNTY IDENTIFICATION FOR NON-DEVELOPMENT USE AMENDMENT

Pursuant to subsection 9(2) of the *Prince Edward Island Lands Protection Act* R.S.P.E.I. 1988, Cap. L-5, Council amended the condition of non-development use made pursuant to section 2 of the Land Identification Regulations (EC606/95) in respect of approximately seventy-two (72) acres of land, being Provincial Property No. 167767 located in Lot 55, Kings County, Prince Edward Island and currently owned by Janet Acorn of Cardigan, Prince Edward Island.
