**ANIMAL HEALTH AND PROTECTION ACT
BEE HEALTH REGULATIONS
AMENDMENT**

Pursuant to section 4 of the *Animal Health and Protection Act* R.S.P.E.I. 1988, Cap. A-11.1, Council made the following regulations:

1. Subsection 1(1) of the *Animal Health and Protection Act* Bee Health Regulations (EC271/01) is amended

(a) in clause (a), by the deletion of the words “, brood and eggs” and the substitution of the words “and brood, but does not include genetic material”; and

(b) by the addition of the following after clause (f):

(f.1) “genetic material” means an egg or sperm produced by a honey genetic material
bee;

2. The regulations are amended by the addition of the following after section 6:

6.1 (1) No person shall transport genetic material into the province unless Genetic material —
restriction

(a) the person holds a genetic material health certificate issued pursuant to subsection (2);

(b) the genetic material originated in Canada; and

(c) the genetic material is transported into the province in the manner specified on the genetic material health certificate.

(2) The provincial apiarist may issue a genetic material health certificate for the transportation of genetic material. Genetic material
health certificate

(3) On issuing a genetic material health certificate under subsection (2), the provincial apiarist shall specify on the certificate the manner in which the genetic material is to be transported into the province. Method of
transportation

3. The regulations are amended by the addition of the following after section 9:

9.1 Where a person ceases to use bee equipment that was used to keep bees, the person shall Used bee equipment

(a) destroy the bee equipment in such a manner as to prevent the spread of brood diseases; or

(b) store the bee equipment in such a manner that is not accessible to bees.

4. These regulations come into force on May 8, 2004.

EXPLANATORY NOTES

These amendments provide for the regulation of the importation of the genetic material of bees. These amendments also require the destruction or storage of bee equipment that is no longer being used to keep bees.
