

EC2007-108**APPRENTICESHIP AND TRADES QUALIFICATION ACT
REGULATIONS
AMENDMENT**

Pursuant to section 10 of the *Apprenticeship and Trades Qualification Act* R.S.P.E.I. 1988, Cap. A-15.1, Council made the following regulations:

1. The *Apprenticeship and Trades Qualification Act* Regulations (EC712/95) are amended by the addition of the following after section 14:

14.1. Subject to the approval of the Minister, the Board may enter into an agreement with any organization or government for the purpose of facilitating or providing apprenticeship related training and the management of any programs concerning such training. Agreements with organizations and governments

2. These regulations come into force on February 28, 2007.

EXPLANATORY NOTES

SECTION 1 authorizes the board to enter into agreements with governments and organizations for the purpose of facilitating apprenticeship related training.

SECTION 2 provides for the commencement of these regulations.
