EXECUTIVE COUNCIL ACT  
PREMIER  
AUTHORITY TO ENTER INTO AN AGREEMENT  
(JOINT DECLARATION FOR THE PURPOSE OF ESTABLISHING  
THE SEUS-CANADIAN PROVINCES ALLIANCE)  
WITH  
THE PARTICIPATING PROVINCES  
AND  
THE SOUTHEASTERN UNITED STATES

Pursuant to clauses 10(b) and (d) of the *Executive Council Act* R.S.P.E.I. 1988, Cap. E-12 Council authorized the Premier to enter into a joint declaration with the Provinces of Manitoba, New Brunswick, Newfoundland and Labrador, Nova Scotia, Ontario, and Quebec, as represented by their respective Premiers or designated Ministers, and the States of Alabama, Florida, Georgia, Mississippi, North Carolina, South Carolina, and Tennessee, as represented by their respective Governors or designated representatives, to establish the Southeastern United States-Central and Eastern Canadian Provinces Alliance to present opportunities to enhance commercial exchanges, promote two-way investment and encourage technological and scientific exchanges between the Provinces and the States, such as more particularly described in the draft agreement.
