**CITY OF SUMMERSIDE ACT
BORROWING AUTHORITY
APPROVED**

Pursuant to subsection 43(2) of the *City of Summerside Act* R.S.P.E.I. 1988, Cap. S-9.1, Council authorized the City of Summerside to increase its borrowing subject to the condition that its total debt will not exceed an amount equal to eight decimal eight per cent (8.8%) of the current assessed value of real property in the city plus the accumulated debt of the City of Summerside's Electric Utility for a period of two years, after which the total allowable accumulated debt of the City of Summerside will return to a maximum of eight per cent (8%) of the current assessed value of real property in the city plus the accumulated debt of the City of Summerside's Electric Utility.

This Order-in-Council comes into force on 27 November 2007.

PRINCE EDWARD ISLAND

PETITION TO ACQUIRE A LAND HOLDING
ÉVANGÉLINE ATV CLUB INC.
