**GASOLINE TAX ACT
REGULATIONS
AMENDMENT**

Pursuant to section 9 of the *Gasoline Tax Act* R.S.P.E.I. 1988, Cap. G-3, Council made the following regulations:

1. The heading immediately before section 1 of the *Gasoline Tax Act Regulations* (EC283/72) is amended by the deletion of the words "TAX ACT" after the word "GASOLINE".

2. Clause 1(1)(d.1) of the regulations is revoked and the following substituted:

(d.1) "farmer" means

(i) an individual, partnership or corporation that is registered in the province, actively engaged in a farming operation and reporting income from the sale of products from the farming operation or from providing custom agricultural services to farmers, or

(ii) an individual, partnership or corporation that is registered in the Future Farmer Program;

farmer

3. Clause 15(1)(d) of the regulations is revoked.

4. Subsection 16(2) of the regulations is amended by the deletion of the words “of the type known as “TEF RED FF 20” or of the type known as “MORTRACE FOM BB”” and the substitution of the words “approved by the Minister”.

5. These regulations come into force on July 19, 2008.

EXPLANATORY NOTES

SECTION 1 amends the wording to the heading under Part I.

SECTION 2 amends the definition of “farmer” to include an individual, partnership or corporation that is registered in the Future Farmer Program.

SECTION 3 revokes a clause exempting the payment of tax in respect of the purchase or consumption of propane gasoline when not used for the operation of an internal combustion engine. Propane gasoline is now exempt of tax.

SECTION 4 amends the provision dealing with gasoline that is to be sold or delivered as marked gasoline. The amendment provides that the dye or chemical marker used is to be approved by the Minister.

SECTION 5 provides for the commencement of these regulations.
