Pursuant to section 5 of the *Prince Edward Island Lands Protection Act* R.S.P.E.I. 1988, Cap. L-5 Council granted permission to the Great Enlightenment Buddhist Institute Society of Stratford, Prince Edward Island to acquire a land holding of approximately twelve (12) acres of land in Lot 59, Kings County, Province of Prince Edward Island, being acquired from Atlantic Resorts Ltd. of Montague, Prince Edward Island.

L-14 Council granted approval to the Prince Edward Island Liquor Control Commission to borrow up to two hundred and seventy thousand (\$270,000.00) dollars from the Provincial Treasurer to undertake renovations to the Stratford Liquor Store.

Morley of Charlottetown in Queens County, Prince Edward Island, as a Justice of the Peace in and for the Counties of Prince, Queens and Kings in the Province of Prince Edward Island for a term of five (5) years, effective 10 February 2009.

Further, Council ordered that should Chesa L. Morley cease to be employed in her present capacity in the Office of the Attorney General, that her appointment as a Justice of the Peace shall terminate coincident with the date her employment terminates.
