L-5, Council amended the condition prohibiting subdivision made in respect of approximately forty-eight decimal one nine (48.19) acres of land, being Provincial Property No. 746818 located in Lot 34, Queens County, Prince Edward Island and currently owned by Elizabeth Young of Little York, Prince Edward Island.

Council noted that this amendment will enable subdivision of a parcel of land of approximately seven decimal five two (7.52) acres, SUBJECT TO the subdivided parcel being consolidated with the adjacent property of approximately two decimal six seven (2.67) acres, currently Provincial Property No. 477554.
