TICKET REGULATIONS  
AMENDMENT**

Pursuant to subsection 10(3) of the *Summary Proceedings Act* R.S.P.E.I. 1988, Cap. S-9, Council made the following regulations:

**1. Part 30 of Schedule 2 of the *Summary Proceedings Act* Ticket Regulations (EC58/08) is amended**

(a) by the revocation of item 23;

(b) by the addition of the following after item 85:

85.1 Driving a vehicle other than an emergency vehicle with a red lamp or device in a location other than the rear of the vehicle.....	114	100

(c) by the revocation of item 98 and the substitution of the following:

98 Operating or permitting to be operated emergency vehicle without siren, etc.....	127(4)	200
98.1 Using sirens or other warning devices when not emergency.....	127(4.1)	200

**SECTION 1** amends the *Summary Proceedings Act* Ticket Regulations to reflect recent amendments made to offences provided for in the *Highway Traffic Act*.

**SECTION 2** provides for the commencement of these regulations.
