IDENTIFICATION FOR NON-DEVELOPMENT USE
AMENDMENT

Pursuant to subsection 9(2) of the *Prince Edward Island Lands Protection Act* R.S.P.E.I. 1988, Cap. L-5, Council amended the condition of non-development use made pursuant to section 2 of the Land Identification Regulations (EC606/95) in respect of approximately seventy-nine (79) acres of land, being Provincial Property No. 454132 located in Lot 4, Prince County, Prince Edward Island and currently owned by Wilkie Farms Ltd. of Alberton, Prince Edward Island.

Council noted that this amendment will enable subdivision of a parcel of land of approximately zero decimal five three (0.53) acres, SUBJECT TO the subdivided parcel being consolidated with the adjacent Provincial Property No. 531616. Further, Council determined that following subdivision, identification for non-development use shall continue to apply to the remaining land.

This Order-in-Council comes into force on 11 October 2011.
