P-25 Council appointed Connie Doucette of North Granville, in Queens County, Prince Edward Island, as a Justice of the Peace in and for the Counties of Prince, Queens and Kings in the Province of Prince Edward Island for a term of five (5) years, effective 19 November 2019.

Further, Council ordered that should Connie Doucette cease to be employed by the Province of Prince Edward Island in her present capacity with the Provincial Court, that her appointment as a Justice of the Peace shall terminate coincident with the date her employment terminates.
