(a) in subclause(a)(ii), by the deletion of the words “to a pharmacist at a pharmacy, directly” and the substitution of the words “to a pharmacist or a pharmacy technician at a pharmacy, directly, by electronic transmission”; and

(b) in clause (b), by the addition of the words “or a pharmacy technician” after the word “pharmacist”.

(2) Subsection 8(3) of the regulations is amended by the addition of the words “or pharmacy technician” after the word “pharmacist”.

2. These regulations come into force on April 10, 2021.

EXPLANATORY NOTES

SECTION 1 amends subsections 8(1) and (3) of the regulations to provide for a pharmacy technician to receive prescriptions in writing or verbally and to provide for prescriptions to be given to a pharmacist or pharmacy technician in writing by electronic transmission.

SECTION 2 provides for the commencement of these regulations.
