PRINCE EDWARD ISLAND  
LANDS PROTECTION ACT  
PROPERTY NO. 821447, LOT 14, PRINCE COUNTY  
IDENTIFICATION FOR NON-DEVELOPMENT USE  
AMENDMENT

Pursuant to subsection 9(2) of the *Prince Edward Island Lands Protection Act* R.S.P.E.I. 1988, Cap. L-5, Council amended the condition of non-development use made pursuant to section 2 of the Land Identification Regulations (EC606/95) in respect of approximately twenty decimal four (20.4) acres of land, being Provincial Property No. 821447 located at Grand River, Lot 14, Prince County, Prince Edward Island and currently owned by Sunnyside Farms Inc. of Richmond, Prince Edward Island.

Council noted that this amendment will enable subdivision of a parcel of land of approximately one decimal six eight (1.68) acres for residential use, provided a sixty-six (66) foot right-of-way is established to access the remainder of the lands, and determined that following subdivision, identification for non-development use shall continue to apply to the remaining land.

This Order-in-Council comes into force on November 23, 2021.
